

PWSSP Adhering LCR Laboratories

The following is a list of laboratories that can analyze samples for compliance with the Lead and Copper Rule (LCR). These laboratories have acknowledged in writing to TCEQ that they have reviewed the Public Water System Supervision Program (PWSSP) Quality Assurance Project Plan (QAPP) Addendum 2, "Guidance for Collection, Analysis and Reporting Lead and Copper Samples Under the Lead and Copper Rule", and agree to adhere to the requirements contained therein. The TCEQ PWSSP recommends using laboratories that are properly accredited in the drinking water matrix and have agreed to adhere to PWSSP requirements. Data from laboratories that do not adhere to PWSSP requirements may be rejected by TCEQ and result in potential violations for the water system.
