ABANDONMENT OF WATER RIGHT

Notice: This form will not be processed until all delinquent fees and/or penalties owed to the TCEQ or the Office of the Attorney General on behalf of the TCEQ are paid in accordance with the Delinquent Fee and Penalty Protocol.

Please note that this action to voluntarily abandon, and the subsequent cancellation of, your water right may not be reversed and obtaining a water right in the future will require a new application for water. New applications require application/notice fees and may or may not be granted, subject to water availability. Additionally, water rights in the State of Texas may add value to the property they are associated with and/or may have a monetary value of their own. Please consider all of this in determining whether you wish to proceed with abandoning your water right.



Certificate of Adjudication No. 12-2951 authorizes diversion of a maximum of 35 acre-feet from the Leon River, Brazos River Basin to irrigate a maximum of 40 acres out of a 97.01 acre tract located in the E. P. Pullium Survey, Abstract 676, Bell County, Texas.

Dear Mr. Montgomery:

As per our phone conversation on November 10th, 2016, enclosed is an *Application to Abandon a Water Right*.

If you want to cancel your water right, you may do so by completing the enclosed *Abandonment Form* and returning it to us. Please fill out the form stating that you wish to abandon the 1.66 acre-foot portion of the water right belonging to your wife and yourself. However, you may wish to retain the water right for the future owner of the property; a water right is a valuable addition to your property.

Please be aware that abandonment is not the only option you have. It can be sold to others in the watershed, and with Commission approval, be used on other lands or even for other purposes. You may market your water right by running an advertisement in your local newspapers.
