I, _____, dba _____, do hereby notify the Texas Commission on Environmental Quality (TCEQ) that I intend to fill land by means of a Land Reclamation Project Using Tires (LRPUT); and I affirm, acknowledge, and certify the following:

- 1) I am familiar with the notification application and supporting information and documents; am aware of all commitments represented in the application; am familiar with and agree to comply with all pertinent regulatory requirements, local building and fire codes, public safety and land use laws, and applicable zoning ordinances; agree to develop and operate the project and site in accordance with the application, TCEQ rules, and any special provisions that may be imposed by the executive director; and that the information that is now or may be later submitted in connection with this project is true and correct to the best of my knowledge.
- 2) I, as property owner, have the responsibility to file an Affidavit to the Public in the county deed records upon completion of the project, advising that a reclamation project utilizing tire pieces exists on the property; that the Affidavit shall contain details of the location of the filled area within the property boundaries, the areal extent of the fill, coordinates and survey data, and approximate weight or volume of tires used; and further, that if I am not the property owner or later sell said property, I am obligated to advise the owner of the responsibility for filing this Affidavit.
- 3) The disturbed area upon and within which the project will take place existed prior to filing this notification application, was not formed or created for this project, and was not excavated for the sole purpose of burying tire pieces.
- 4) This LRPUT will be completed in a manner that will comply with all regulations set forth in this subchapter, as well as all other TCEQ rules and rules of any other local, state, or federal agency that may apply.
- 5) The local fire marshal or fire chief having jurisdiction in the site area has been notified of this proposed fill activity, and that arrangements have been made for fire fighting assistance and other emergency response support.
- 6) A copy of the notification documents and attachments have been mailed (by Certified Mail--Return Receipt Requested) to the appropriate mayor and/or county judge, and to the appropriate regional Council of Governments, in whose jurisdictions the project is located.
- 7) I have provided notice of this project to the general public by means of publication in the local newspaper, and to landowners adjacent to and within 500 feet of the site by Certified Mail--Return Receipt Requested; as specified in Title 30 of the Texas Administrative Code, Subchapter F, § 328.66(a)(10).
- 8) Upon my completion of all fill activities related to the project, I am to submit to the TCEQ executive director a Certification of Completion; which has been prepared, sealed, signed, and dated by a Licensed Professional Engineer; certifying that the project has been completed in accordance with the TCEQ rules and the information and documents contained in the notification application.
