Re: Motion for Rehearing filed by Madison Ridlehuber regarding a Default Order concerning Ann Ridlehuber; TCEQ Docket No. 2020-0875-IHW-E.

The above-referenced Motion for Rehearing (Motion) was filed by James Rainey, an attorney with Rainey & Rainey, on behalf of Madison Ridlehuber (Movant) on September 7, 2022, regarding a Default Order concerning Ann Ridlehuber.

Texas Government Code § 2001.146(e) and Title 30 of the Texas Administrative Code Chapter 80 authorize an extension of time for acting on a Motion for Rehearing up to 100 days after the date that the order is signed. In this case, the Commission order was signed on August 25, 2022. This letter serves as the order extending the time for the Commission to act on the Motion until **Monday, December 5, 2022**.

This letter also notifies the Executive Director and the Office of Public Interest Counsel that they are encouraged to file response briefs with the Commission's Office of Chief Clerk (OCC) on or before **5:00 P.M. on Friday, September 30, 2022**. The Movant may file a reply brief on or before **5:00 P.M. on Friday, October 14, 2022**.

All responses and replies must be properly filed with the Chief Clerk of the TCEQ. Responses and replies may be filed with the Chief Clerk electronically at <https://www.tceq.texas.gov/goto/efilings> *or* by filing an original and seven (7) copies with the Chief Clerk of the TCEQ. All response and reply briefs should also be mailed to all other persons on the attached mailing list on the same day filed in the OCC. To be considered timely, any response or reply brief must be received in the OCC on or before the applicable 5:00 P.M. deadline. All briefs filed with the OCC should be addressed to the attention of the Agenda Docket Clerk and marked with the TCEQ Docket number provided above.

After the Office of General Counsel (OGC) has reviewed the filings, OGC will determine whether to set this matter on an upcoming Commission Agenda.
