Dear Judges Farhadi and Robles,

This letter is submitted on behalf of the City of Liberty Hill ("City") in reply to Stephanie Morris' November 30<sup>th</sup> letter regarding exceptions to the Supplemental Proposal for Decision ("Supplemental PFD") issued in this docket.

Ms. Morris asks the Court to revise the Total Phosphorus (TP) effluent limit in proposed finding 113 from 0.15 mg/L to 0.015 mg/L. To the extent that proposed finding 113 has a typo, the City excepts to this change on the same basis as argued in its exceptions to the Supplemental PFD in Sections II, A, B, and D. A TP limit of 0.015 mg/L violates TCEQ's rules, is a troublesome precedent calling into question the legality of every other TPDES Permit issued by the TCEQ, and is a result of misapplying the Texas Surface Water Quality Standards to require an applicant to improve water quality rather than maintain water quality and prevent degradation of water quality.

The City reserves the right to respond to all exceptions and responses to exceptions before the Commission.
