Protestant Morris files this letter, in lieu of exceptions, in response to the ALJs' Supplemental Proposal for Decision on Remand issued on November 10, 2023. Protestant Morris supports the ALJs' proposed order and has no exceptions to the ALJs' Supplemental PFD on Remand, and files this letter only to recommend minor clarifications to the following material proposed Findings of Fact:

- The following should be added as proposed Finding of Fact No. 38 (and the remaining findings of fact be renumbered accordingly): "On July 21, 2023, the ALJs convened a prehearing conference via videoconference. All parties appeared through their respective representatives and the ALJs addressed pending motions and matters pertinent to the remand hearing organization."
- Consistent with the Supplemental PFD on Remand, proposed Finding of Fact No. 113 should read: "The TP effluent limit necessary to prevent excessive algal growth that impairs primary contact recreation use in 0.015 mg/L." This corrects a typographical error that read "0.15 mg/L."

Protestant Morris reserves the right to file a response to exceptions filed by other parties.
