Violation Information

- 1. Failed to submit an initial notification for a reportable emissions event no later than 24 hours after the discovery of an emissions event. Specifically, the initial notification for Incident No. 360105 was due by June 13, 2021 at 4:04 a.m., but was not submitted until June 15, 2021 at 8:30 a.m. [30 Tex. Admin. Code §§ 101.201(a)(1)(B) and 122.143(4), Federal Operating Permit ("FOP") No. O2294, General Terms and Conditions ("GTC") and Special Terms and Conditions ("STC") No. 2.F, and Tex. Health & Safety Code § 382.085(b)].
- 2. Failed to prevent unauthorized emissions. Specifically, the Respondent released 10,778.97 pounds of volatile organic compounds from Natsyn Wastewater, Emissions Point Number 330WF, during an emissions event (Incident No. 360105) that occurred on June 12, 2021 and lasted six hours and two minutes. The emissions event occurred when the float for the Water Level Control on the C Decanter became stuck and the downstream capacitance probe that acts as a failsafe was malfunctioning, allowing the discharge valve for the C Decanter to remain open and resulting in the release to the atmosphere. Since the Respondent did not comply with the emissions event reporting requirements, the emissions event was not caused by a sudden unavoidable breakdown of equipment or process beyond the control of the owner or operator, and the emissions could have been avoided by better design and/or better operational and maintenance practices, the Respondent is precluded from asserting an affirmative defense under 30 Tex. Admin. Code § 101.222 [30 Tex. Admin. Code §§ 116.115(c) and 122.143(4), New Source Review Permit No. 22110, Special Conditions No. 1, FOP No. O2294, GTC and STC No. 19, and Tex. Health & Safety Code § 382.085(b)].

Corrective Actions/Technical Requirements

The Respondent implemented the following corrective measures:

- a. In order to prevent the recurrence of emissions events due to the same or similar causes as Incident No. 360105:
- i. On June 14, 2021, replaced the float for the Water Level Control on the C Decanter and scheduled updated annual preventative maintenance procedures for the float;
- ii. On July 1, 2021, replaced the downstream capacitance probe; and
- iii. On July 17, 2021, cleaned the C Decanter.
- b. On June 15, 2021, submitted the initial notification for Incident No. 360105.

c. By October 11, 2021, met with the Process Unit Team Leaders regarding proper communication for abnormal conditions, assigned a computer based training module to all Plant personnel to explain the cause of the emissions event, retrained personnel on the emissions event reporting requirements, and instructed personnel to re-review the Goodyear Beaumont Standard Environmental Release Reporting standard in order to ensure that the initial notifications for reportable emissions events are submitted in a timely manner.

AGREED ORDER DOCKET NO. 2021-1084-AIR-E

I. JURISDICTION AND STIPULATIONS

On	the Texas Commission on Environmental Quality ("the
Commission" or "	CEQ") considered this agreement of the parties, resolving an enforcement
action regarding T	he Goodyear Tire & Rubber Company (the "Respondent") under the authority
of TEX. HEALTH &	SAFETY CODE ch. 382 and TEX. WATER CODE ch. 7. The Executive Director of
the TCEQ, through	the Enforcement Division, and the Respondent together stipulate that:

- 1. The Respondent owns and operates a synthetic rubber manufacturing plant located at 11241 Interstate Highway 10 near Beaumont, Jefferson County, Texas (the "Plant"). The Plant consists or consisted of one or more sources as defined in Tex. Health & Safety Code § 382.003(12).
- 2. The Executive Director and the Respondent agree that the TCEQ has jurisdiction to enter this Order pursuant to Tex. Water Code §§ 7.002, 7.051, and 7.073, and that the Respondent is subject to TCEQ's jurisdiction. The TCEQ has jurisdiction in this matter pursuant to Tex. Water Code § 5.013 because it alleges violations of Tex. Health & Safety Code ch. 382 and the rules of the TCEQ.
- 3. The occurrence of any violation is in dispute and the entry of this Order shall not constitute an admission by the Respondent of any violation alleged in Section II ("Allegations"), nor of any statute or rule.
- 4. An administrative penalty in the amount of \$9,625 is assessed by the Commission in settlement of the violations alleged in Section II ("Allegations"). The Respondent paid \$7,700 of the penalty and \$1,925 is deferred contingent upon the Respondent's timely and satisfactory compliance with all the terms of this Order. The deferred amount shall be waived only upon full compliance with all the terms and conditions contained in this Order. If the Respondent fails to timely and satisfactorily comply with any of the terms or requirements contained in this Order, the Executive Director may demand payment of all or part of the deferred penalty amount.
- 5. The Executive Director and the Respondent agree on a settlement of the matters alleged in this enforcement action, subject to final approval in accordance with 30 TEX. ADMIN.

CODE § 70.10(a). Any notice and procedures, which might otherwise be authorized or required in this action, are waived in the interest of a more timely resolution of the matter.

- 6. The Executive Director may, without further notice or hearing, refer this matter to the Office of the Attorney General of the State of Texas ("OAG") for further enforcement proceedings if the Executive Director determines that the Respondent has not complied with one or more of the terms or conditions in this Order.
- 7. This Order represents the complete and fully-integrated agreement of the parties. The provisions of this Order are deemed severable and, if a court of competent jurisdiction or other appropriate authority deems any provision of this Order unenforceable, the remaining provisions shall be valid and enforceable.
- 8. This Order shall terminate five years from its effective date or upon compliance with all the terms and conditions set forth in this Order, whichever is later.
- 9. The Executive Director recognizes that the Respondent implemented the following corrective measures at the Plant:
 - a. In order to prevent the recurrence of emissions events due to the same or similar causes as Incident No. 360105:
 - i. On June 14, 2021, replaced the float for the Water Level Control on the C Decanter and scheduled updated annual preventative maintenance procedures for the float;
 - ii. On July 1, 2021, replaced the downstream capacitance probe; and
 - iii. On July 17, 2021, cleaned the C Decanter.
 - b. On June 15, 2021, submitted the initial notification for Incident No. 360105.
 - c. By October 11, 2021, met with the Process Unit Team Leaders regarding proper communication for abnormal conditions, assigned a computer based training module to all Plant personnel to explain the cause of the emissions event, retrained personnel on the emissions event reporting requirements, and instructed personnel to re-review the Goodyear Beaumont Standard Environmental Release Reporting standard in order to ensure that the initial notifications for reportable emissions events are submitted in a timely manner.

II. ALLEGATIONS

During a record review conducted on July 26, 2021, an investigator documented that the Respondent:

1. Failed to submit an initial notification for a reportable emissions event no later than 24 hours after the discovery of an emissions event, in violation of 30 Tex. Admin. Code §§ 101.201(a)(1)(B) and 122.143(4), Federal Operating Permit ("FOP") No. O2294, General Terms and Conditions ("GTC") and Special Terms and Conditions ("STC") No.

- 2.F, and TEX. HEALTH & SAFETY CODE § 382.085(b). Specifically, the initial notification for Incident No. 360105 was due by June 13, 2021 at 4:04 a.m., but was not submitted until June 15, 2021 at 8:30 a.m.
- 2. Failed to prevent unauthorized emissions, in violation of 30 TEX. ADMIN. CODE §§ 116.115(c) and 122.143(4), New Source Review Permit No. 22110, Special Conditions No. 1, FOP No. O2294, GTC and STC No. 19, and TEX. HEALTH & SAFETY CODE § 382.085(b). Specifically, the Respondent released 10,778.97 pounds of volatile organic compounds from Natsyn Wastewater, Emissions Point Number 330WF, during an emissions event (Incident No. 360105) that occurred on June 12, 2021 and lasted six hours and two minutes. The emissions event occurred when the float for the Water Level Control on the C Decanter became stuck and the downstream capacitance probe that acts as a failsafe was malfunctioning, allowing the discharge valve for the C Decanter to remain open and resulting in the release to the atmosphere. Since the Respondent did not comply with the emissions event reporting requirements, the emissions event was not caused by a sudden unavoidable breakdown of equipment or process beyond the control of the owner or operator, and the emissions could have been avoided by better design and/or better operational and maintenance practices, the Respondent is precluded from asserting an affirmative defense under 30 Tex. ADMIN. CODE § 101.222.

III. DENIALS

The Respondent generally denies each allegation in Section II ("Allegations").

IV. ORDERING PROVISIONS

NOW, THEREFORE, THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY ORDERS that:

1. The Respondent is assessed a penalty as set forth in Section I, Paragraph No. 4. The payment of this penalty and the Respondent's compliance with all of the requirements set forth in this Order resolve only the allegations in Section II. The Commission shall not be constrained in any manner from requiring corrective action or penalties for violations which are not raised here. Penalty payments shall be made payable to "TCEQ" and shall be sent with the notation "Re: The Goodyear Tire & Rubber Company, Docket No. 2021-1084-AIR-E" to:

- 2. All relief not expressly granted in this Order is denied.
- 3. The duties and provisions imposed by this Order shall apply to and be binding upon the Respondent. The Respondent is ordered to give notice of this Order to personnel who maintain day-to-day control over the Plant operations referenced in this Order.

- 4. The Executive Director may grant an extension of any deadline in this Order or in any plan, report, or other document submitted pursuant to this Order, upon a written and substantiated showing of good cause. All requests for extensions by the Respondent shall be made in writing to the Executive Director. Extensions are not effective until the Respondent receives written approval from the Executive Director. The determination of what constitutes good cause rests solely with the Executive Director.
- 5. This Order, issued by the Commission, shall not be admissible against the Respondent in a civil proceeding, unless the proceeding is brought by the OAG to: (1) enforce the terms of this Order; or (2) pursue violations of a statute within the Commission's jurisdiction, or of a rule adopted or an order or permit issued by the Commission under such a statute.
- This Order may be executed in separate and multiple counterparts, which together shall 6. constitute a single instrument. Any page of this Order may be copied, scanned, digitized, converted to electronic portable document format ("pdf"), or otherwise reproduced and may be transmitted by digital or electronic transmission, including but not limited to facsimile transmission and electronic mail. Any signature affixed to this Order shall constitute an original signature for all purposes and may be used, filed, substituted, or issued for any purpose for which an original signature could be used. The term signature" shall include manual signatures and true and accurate reproductions of manual signatures created, executed, endorsed, adopted, or authorized by the person or persons to whom the signatures are attributable. Signatures may be copied or reproduced digitally, electronically, by photocopying, engraving, imprinting, lithographing, electronic mail, facsimile transmission, stamping, or any other means or process which the Executive Director deems acceptable. In this paragraph exclusively, the terms: electronic transmission, owner, person, writing, and written, shall have the meanings assigned to them under TEX. BUS. ORG. CODE § 1.002.
- 7. The effective date of this Order is the date it is signed by the Commission. A copy of this fully executed Order shall be provided to each of the parties.
