EXECUTIVE DIRECTOR'S RESPONSE TO MOTION TO OVERTURN

The Executive Director of the Texas Commission on Environmental Quality (TCEQ or Commission) files this Response to Bell County Commissioner Bill Schumann's (Commissioner Schumann or Movant) Motion to Overturn the Executive Director's decision to approve the application by Roadrunner Express, LLC (Roadrunner) for new Registration No. 170067 to authorize a new scrap tire facility. Commissioner Schumann filed a timely Motion to Overturn (MTO) the Executive Director's decision in accordance with 30 Texas Administrative Code (TAC) Section (§) 50.139. Commissioner Schumann requests that the Commission overturn the Executive Director's approval of the issuance of a scrap tire facility registration because it fails to comply with county policies and TCEQ rules, including notice requirements under 30 TAC Chapter 328, Subchapter F.

As detailed below, the Executive Director respectfully recommends that the Commission grant the MTO and overturn the Executive Director's decision on the registration.

I. Background

Registration No. 170067 is issued to Roadrunner Express, LLC, and authorizes the processing of used and/or scrap tires, or tire pieces and to store a maximum of 500 used or scrap

tires (or the equivalent in tire pieces) on the ground or 2,000 used or scrap tires (or the equivalent in tire pieces) in totally enclosed lockable containers at 14650 Dove Rd., Moody, Texas 76557 (Facility).

TCEQ received Roadrunner's scrap tire facility registration application (Application) on August 11, 2021. TCEQ completed a review of the Application and provided a Notice of Deficiencies (NOD) on August 18, 2021. Subsequently, the Application was revised several times.¹ After consideration of public comments, statutory requirements, and regulatory requirements, the Executive Director issued and mailed the registration on October 14, 2021. Pursuant to 30 TAC § 50.139, the deadline to file a MTO was November 8, 2021. Commissioner Schumann timely filed the MTO on November 8, 2021. As allowed by 30 TAC § 50.139(e), the Office of the General Counsel issued a letter on November 22, 2021 extending the Commission's time to act on this matter until January 12, 2022.

A summary of the concerns raised in the MTO and the Executive Director's response follows.

II. Discussion of Issues Raised by Movant

A. Notice Concerns

Commissioner Schumann states that notice was not provided to either the Bell County Judge or any other member of the Bell County Commissioners Court. A notice letter was sent to Henry Garza, Bell County District Attorney, but he did not contact the Bell County Commissioners Court.

Commissioner Schumann also states that notice was not provided to the County Fire Marshall. Notice was provided to the Moffat Volunteer Fire Department. However, fire emergency calls go to the county dispatcher where the County Fire Marshall is notified and coordinates emergency resources.

Commissioner Schumann states that although notice was provided to the Central Texas Council of Governments (COG), the COG plays no role in the processing, disposition, or ultimate cleanup of a scrap tire facility.

Executive Director's Response

TCEQ rules governing the management of used or scrap tires are primarily found in 30 TAC Chapter 328, Subchapter F. Applicable rules for registration applications for scrap tire facilities provide that an owner or operator "shall mail a copy of the notification documents and attachments to . . . the appropriate county judge if the proposed project is to be located within an unincorporated area of a county; to the appropriate regional council of government; and, to the appropriate local fire authority. Proof of mailing shall be provided in the form of return receipts for registered mail." 30 TAC § 328.63(d)(1).

a. County Judge

As provided in the Application, the proposed Facility will be located within an unincorporated area of Bell County, Texas.² Receipts provided by Roadrunner in its application

indicate notice was mailed to Henry Garza, the district attorney for Bell County, located at the Bell County Justice Center, 1201 Huey Rd., Ste. 2100, Belton, Texas 76513.³ However, it appears that the notice was not provided to David Blackburn, the County Judge of Bell County. It is unclear why Roadrunner chose to mail notice to the office of the district attorney rather than the County Judge; however, from the Application it appears that Roadrunner failed to provide notice to the county judge as required by 30 TAC § 328.63(d)(1). Because Roadrunner failed to satisfy a necessary notice requirement regarding notice to the County Judge, its scrap tire facility registration application is deficient. Therefore, the Executive Director respectfully recommends that the Commission grant Commissioner Schumann’s MTO and overturn the Executive Director’s decision on the registration.

b. Appropriate Fire Authority

Roadrunner provided notice to both the Moffat Volunteer Fire Department and the Moody Volunteer Fire Department.⁴ In response to Roadrunner’s notice, Scott Benson, Fire Chief of the Moffat Volunteer Fire Department, stated the Facility is in the Moffat Volunteer Fire Department district and will be “dispatched for any emergencies that you may have Including [sic] Fire or Emergency Medical Services.”⁵ Given these assurances, it is clear the Moffat Volunteer Fire Department is an “appropriate local fire authority.” See 30 TAC § 328.63(d)(1). Therefore, Roadrunner satisfied the applicable notice requirement in 30 TAC § 328.63(d)(1) by providing notice to an appropriate local fire authority—the Moffat Volunteer Fire Department.

c. Regional Council of Government

As stated above, the rules require operators of scrap tire facilities to notify “the appropriate regional council of government.” 30 TAC § 328.63(d)(1). Whether Commissioner Schumann believes COGs “play no role in the processing or disposition or ultimate clean up of a scrap tire facility” is irrelevant because Roadrunner satisfied the requirement by providing notice to the Central Texas Council of Governments, the appropriate regional council of government for Bell County.⁶

B. Complaints and Enforcement Action at Similarly Situated Facilities

Commissioner Schumann states Bell County has several existing scrap tire facilities, including those that have been subject to TCEQ enforcement actions.

Executive Director’s Response

The Executive Director does not consider the compliance history of other unrelated persons when evaluating the compliance history of an applicant. See 30 TAC § 60.3. The Executive Director examined Roadrunner’s compliance history; the compliance history report for Roadrunner does not demonstrate any past, present, or pending enforcement actions or violations.⁷

C. Health Concerns

Commissioner Schumann states the permitted 500 tires stored outside at the Facility may

increase the incidence of Zika Virus, which conflicts with Bell County Public Health District initiatives.

Executive Director's Response

TCEQ rules governing the management of scrap tire facilities require that used or scrap tire pieces awaiting “processing . . . shall be monitored for vector control and appropriate vector control measures shall be applied when needed, but in no event less than once every two weeks.” 30 TAC § 328.63(d)(3). The TCEQ scrap tire facility registration application form asks applicants to describe the method for controlling vectors, such as mosquitos and rodents. In its updated application, Roadrunner stated it would “[T]reat [scrap and used tires] with insecticide and repellants a minimum of [t]wice a month or as needed to control vectors.”⁸ Accordingly, Roadrunner’s stated vector control measures are sufficient to meet applicable TCEQ rules.

TCEQ’s scrap tire rules do not “preempt local ordinances regarding the management of used or scrap tires that are as or more stringent than the regulations in [Chapter 328, Subchapter F.]” 30 TAC § 328.52(a). Those regulated by the rules in Subchapter F must “comply with all applicable local ordinances that are not inconsistent with the regulations” in Subchapter F. *Id.* Where local ordinances “require controls and records more stringent than the requirements of [Subchapter F], scrap tire facility operators shall use those criteria to satisfy commission requirements under this section.” 30 TAC § 328.63(d)(2). Prior to approval, the Executive Director is required to “consider any timely written notification by a local government with jurisdiction . . . that the proposed facility does not comply with local requirements” *Id.* Commissioner Schumann did not identify any Bell County ordinance(s) requiring more stringent vector control measures than the requirements in TCEQ’s rules.

D. Additional Concerns

1. Commissioner Schumann states that Bell County lacks the resources to monitor local scrap tire facilities and questions whether TCEQ will adequately monitor the number of used or scrap tires at the Facility.

Executive Director's Response

TCEQ jurisdiction is established by the Legislature and is limited to the issues set forth in statute and rules. TCEQ has not been given authority to assess a county’s resources to regulate scrap tire facilities when determining whether to approve or deny a registration application for a scrap tire facility in that county. *See* 30 TAC § 328.54-55; *see also* 30 TAC § 328.63

Owners or operators of scrap tire facilities that violate applicable TCEQ rules are subject to any “action authorized by law to secure compliance, including the assessment of administrative penalties or civil penalties” 30 TAC § 328.54(a). The Executive Director may “annul, suspend, or revoke a registration . . . for failure to comply with any rule or order issued by the commission,” including the illegal storage of used or scrap tires above the quantities allowed in Registration No. 170067.⁹ 30 TAC § 328.55(6).

Individuals are encouraged to report their concerns regarding suspected noncompliance with terms of any TCEQ authorization or environmental regulation by calling TCEQ’s 24-hour toll-free Environmental Complaints Hotline at 1-888-777-3186 or by sending an e-mail to complaint@tceq.texas.gov. TCEQ investigates all complaints. If a person or facility is found to be

out of compliance with the terms and conditions of an issued authorization, rule, or law, the person or facility may be subject to enforcement action.

2. Commissioner Schumann suggests that TCEQ require a bond or other financial assurances for cleanup purposes.

Executive Director's Response

Financial assurance is not required for scrap tire facilities, but is required for scrap tire storage sites. *See* 30 TAC § 328.53(19)-(20); *see* 30 TAC § 328.60(b)(1), (b)(10)(D); *see generally* 30 TAC § 328.71; *see also* 30 TAC § 328.63; *see also* 30 TAC § 37.3001. Because Registration No. 170067 is a scrap tire facility rather than a scrap tire storage site, Roadrunner is not required to provide financial assurance for the Facility.

III. CONCLUSION

The Executive Director has re-evaluated the Application and reviewed the issued registration in light of the issues raised by Commissioner Schumann. The Executive Director concludes this registration is deficient because Roadrunner's scrap tire facility registration application failed to meet a necessary notice requirement pursuant to 30 TAC § 328.63(d)(1). The Executive Director respectfully recommends that the Commission grant Commissioner Schumann's MTO and overturn the Executive Director's decision on the registration, so Roadrunner may resubmit a complete registration application, including the required notice.
