Our firm has been retained by Chambers County, Texas to represent Chambers County with respect to the above referenced protest and request for hearing in relation to the creation of Chambers County Municipal Utility District No. 4.

On November 23, 2021, the Chambers County Commissioners Court passed a Resolution protesting the creation of the proposed Municipal Utility District 4. Chambers County subsequently filed its protest with the TCEQ and requested a contested case hearing in this matter.

On February 8, 2022, the Chambers County Commissioner’s Court ordered that its November 23, 2021 Resolution protesting the creation of the Municipal Utility District 4 be rescinded and that the prior request for a contested case hearing be withdrawn.
