

Laura Del Murray files this Notice of Opposition to the water rights permit for the City of Wichita Falls regarding the project identified as proposed Lake Ringgold. Laura Del Murray also requests that the Texas Commission on Environmental Quality refer this application for permit to a contested case hearing.

Mrs. Murray owns property that would be directly affected by proposed Lake Ringgold. This property is traversed by the East Fork of the Little Wichita river.
