2. Failed to conduct chloramine effectiveness sampling to ensure that monochloramine is the prevailing chloramine species and that nitrification is controlled [30 TEX. ADMIN. CODE § 290.110(c)(5) and TCEQ Agreed Order Docket No. 2020-0113-PWS-E, Ordering Provision No. 2.a.i].
3. Failed to obtain an exception prior to using blended water containing free chlorine and water containing chloramines [30 TEX. ADMIN. CODE § 290.42(e)(3)(G) and TCEQ Agreed Order Docket No. 2020-0113-PWS-E, Ordering Provision No. 2.c.ii].
4. Failed to ensure that clearwells and potable water storage tanks, including associated appurtenances such as valves, pipes, and fittings, are thoroughly tight against leakage [30 TEX. ADMIN. CODE § 290.43(c)(6)].
5. Failed to ensure all potable water storage tanks and pressure maintenance facilities are installed in a lockable building that is designed to prevent intruder access or enclosed by an intruder-resistant fence with lockable gates [30 TEX. ADMIN. CODE § 290.43(e)].
6. Failed to create a nitrification action plan for all systems distributing chloraminated water [30 TEX. ADMIN. CODE § 290.46(z)].
7. Failed to maintain a disinfectant residual of at least 0.5 milligrams per liter (“mg/L”) of chloramine (measured as total chlorine) throughout the distribution system [30 TEX. ADMIN. CODE §§ 290.46(d)(2)(B) and 290.110(b)(4) and TEX. HEALTH & SAFETY CODE § 341.0315(c)].
8. Failed to maintain the Facility's storage tanks in strict accordance with current American Water Works Association (“AWWA”) standards with an overflow pipe that terminates downward with a gravity-hinged and weighted cover tightly fitted with no gap over 1/16 inch, in violation of 30 TEX. ADMIN. CODE § 290.43(c)(3).
9. Failed to provide the ground storage tank (“GST”) with a gooseneck roof vent or a roof ventilator designed by an engineer and installed in strict accordance with AWWA standards and equipped with a corrosion-resistant 16-mesh or finer screen [30 TEX. ADMIN. CODE § 290.43(c)(1)].
10. Failed to provide two or more service pumps having a total capacity of 2.0 gallons per minute (“gpm”) per connection [30 TEX. ADMIN. CODE § 290.45(b)(1)(D)(iii) and 290.45(b)(1)(C)(i) and TEX. HEALTH & SAFETY CODE § 341.0315(c)].

- a. On October 20, 2022, the chloramine disinfectant residual was raised to 1.29 mg/L;
- b. On October 21, 2022, the overflow on the GST at the Crooked Creek Plant was repaired;
- c. On October 21, 2022, the roof vent was re-installed on the top of the GST at the Crooked Creek Plant;
- d. On April 26, 2023, the leak at the Wilson Plant was repaired;
- e. On March 26, 2024, the trees over the pressure tank at the Academy Plant were removed;
- f. On March 26, 2024, chloramine effectiveness sampling to ensure that monochloramine is the prevailing species and that nitrification is controlled was conducted;
- g. On March 26, 2024, the barbed wire on the front portion of the Wilson Plant fence was installed; and
- h. On March 29, 2024, submitted a nitrification action plan.

**Technical Requirements:**

The Order will require the Respondent to:

- a. Within 90 days, obtain an exception from the Executive Director for the use of blended water containing chloramines and water containing free chlorine or cease blending;
- b. Within 105 days, submit written certification to demonstrate compliance with a.;
- c. Within 180 days, provide two or more service pumps with a total capacity of at least 2.0 gpm per connection at the Davilla Pressure Plane and Rogers Pressure Plane and at least 0.6 gpm per connection of production capacity at the Wilson Plant Pressure Plane; and
- d. Within 195 days, submit written certification to demonstrate compliance with c.

## AGREED ORDER DOCKET NO. 2022-1618-PWS-E

On \_\_\_\_\_, the Texas Commission on Environmental Quality ("the Commission" or "TCEQ") considered this agreement of the parties, resolving an enforcement action regarding Bell-Milam-Falls Water Supply Corporation (the "Respondent") under the authority of TEX. HEALTH & SAFETY CODE ch. 341. The Executive Director of the TCEQ, through the Enforcement Division, and the Respondent presented this Order to the Commission.

The Respondent understands that it has certain procedural rights at certain points in the enforcement process, including the right to formal notice of violations, notice of an evidentiary hearing, the right to an evidentiary hearing, and a right to appeal. By entering into this Order, the Respondent agrees to waive all notice and procedural rights.

It is further understood and agreed that this Order represents the complete and fully-integrated agreement of the parties. The provisions of this Order are deemed severable and, if a court of competent jurisdiction or other appropriate authority deems any provision of this Order unenforceable, the remaining provisions shall be valid and enforceable. The duties and responsibilities imposed by this Order are binding upon the Respondent.

The Commission makes the following Findings of Fact and Conclusions of Law:

### I. FINDINGS OF FACT

1. The Respondent owns and operates a public water supply located at 462 West Farm-to-Market Road 485 near Cameron, Bell County, Texas (the "Facility"). The Facility provides water for human consumption, has approximately 2,150 service connections, and serves at least 25 people per day for at least 60 days per year. As such, the Facility is a public water system as defined in 30 TEX. ADMIN. CODE § 290.38(73).
2. During an investigation at the Facility conducted on October 12, 2022 through October 13, 2022, an investigator documented that:
  - a. There were trees hanging over the pressure tank at the Academy Plant.
  - b. The Respondent did not conduct chloramine effectiveness sampling to ensure that monochloramine is the prevailing chloramine species and that nitrification is controlled.

- c. The Respondent blended ground water containing free chlorine with chloraminated water received from Central Texas Water Supply Corporation and had not obtained an exception.
  - d. The associated appurtenances located near the ground storage tank ("GST") were leaking at the Wilson Plant.
  - e. The barbed wire on the front portion of the fence at the Wilson Plant was missing.
  - f. The Respondent did not create a nitrification action plan for all systems distributing chloraminated water.
  - g. On October 12, 2022, a total chlorine concentration of 0.01 milligrams per liter ("mg/L") was measured at the flush valve located at 855 Capital Lane.
  - h. The end of the overflow pipe was broken off of the GST overflow piping at the Crooked Creek Plant.
  - i. The roof vent was broken off of the top of the GST at the Crooked Creek Plant.
  - j. The Davilla Pressure Plane had 259 connections requiring a service pump capacity of 518 gallons per minute ("gpm"). However, only 410 gpm of service pump capacity were provided, indicating a 20% deficiency. The Rogers Pressure Plane, which provides passthrough service to the Wilson Pressure Plane, had 612 connections requiring 2.0 gpm per connection for service pump capacity. The Wilson Pressure Plane had 101 connections requiring 0.6 gpm per connection for production capacity with a total required service pump capacity of 1,284 gpm. However, only 700 gpm of service pump capacity were provided to both pressure planes, indicating a 45% deficiency.
3. The Executive Director recognizes that the Respondent implemented the following corrective measures at the Facility:
- a. On October 20, 2022, the chloramine disinfectant residual was raised to 1.29 mg/L;
  - b. On October 21, 2022, the overflow on the GST at the Crooked Creek Plant was repaired;
  - c. On October 21, 2022, the roof vent was re-installed on the top of the GST at the Crooked Creek Plant;
  - d. On April 26, 2023, the leak at the Wilson Plant was repaired;
  - e. On March 26, 2024, the trees over the pressure tank at the Academy Plant were removed;

- f. On March 26, 2024, chloramine effectiveness sampling to ensure that monochloramine is the prevailing species and that nitrification is controlled was conducted;
- g. On March 26, 2024, the barbed wire on the front portion of the Wilson Plant fence was installed; and
- h. On March 29, 2024, submitted a nitrification action plan.

## II. CONCLUSIONS OF LAW

1. As evidenced by Finding of Fact No. 1, the Respondent is subject to the jurisdiction of the TCEQ pursuant to TEX. HEALTH & SAFETY CODE ch. 341 and the rules of the TCEQ.
2. As evidenced by Finding of Fact No. 2.a, the Respondent failed to initiate maintenance and housekeeping practices to ensure the good working condition and general appearance of the system's facilities and equipment, in violation of 30 TEX. ADMIN. CODE § 290.46(m) and TCEQ Agreed Order Docket No. 2020-0113-PWS-E, Ordering Provision No. 2.a.iii.
3. As evidenced by Finding of Fact No. 2.b, the Respondent failed to conduct chloramine effectiveness sampling to ensure that monochloramine is the prevailing chloramine species and that nitrification is controlled, in violation of 30 TEX. ADMIN. CODE § 290.110(c)(5) and TCEQ Agreed Order Docket No. 2020-0113-PWS-E, Ordering Provision No. 2.a.i.
4. As evidenced by Finding of Fact No. 2.c, the Respondent failed to obtain an exception, in accordance with 30 TEX. ADMIN. CODE § 290.39(l), prior to using blended water containing free chlorine and water containing chloramines, in violation of 30 TEX. ADMIN. CODE § 290.42(e)(3)(G) and TCEQ Agreed Order Docket No. 2020-0113-PWS-E, Ordering Provision No. 2.c.ii.
5. As evidenced by Finding of Fact No. 2.d, the Respondent failed to ensure that clearwells and potable water storage tanks, including associated appurtenances such as valves, pipes, and fittings, are thoroughly tight against leakage, in violation of 30 TEX. ADMIN. CODE § 290.43(c)(6).
6. As evidenced by Finding of Fact No. 2.e, the Respondent failed to ensure all potable water storage tanks and pressure maintenance facilities are installed in a lockable building that is designed to prevent intruder access or enclosed by an intruder-resistant fence with lockable gates, in violation of 30 TEX. ADMIN. CODE § 290.43(e).
7. As evidenced by Finding of Fact No. 2.f, the Respondent failed to create a nitrification action plan for all systems distributing chloraminated water, in violation of 30 TEX. ADMIN. CODE § 290.46(z).
8. As evidenced by Finding of Fact No. 2.g, the Respondent failed to maintain a disinfectant residual of at least 0.5 mg/L of chloramine (measured as total chlorine)

throughout the distribution system, in violation of 30 TEX. ADMIN. CODE §§ 290.46(d)(2)(B) and 290.110(b)(4) and TEX. HEALTH & SAFETY CODE § 341.0315(c).

9. As evidenced by Finding of Fact No. 2.h, the Respondent failed to maintain the Facility's storage tanks in strict accordance with current American Water Works Association ("AWWA") standards with an overflow pipe that terminates downward with a gravity-hinged and weighted cover tightly fitted with no gap over 1/16 inch, in violation of 30 TEX. ADMIN. CODE § 290.43(c)(3).
10. As evidenced by Finding of Fact No. 2.i, the Respondent failed to provide the GST with a gooseneck roof vent or a roof ventilator designed by an engineer and installed in strict accordance with AWWA standards and equipped with a corrosion-resistant 16-mesh or finer screen, in violation of 30 TEX. ADMIN. CODE § 290.43(c)(1).
11. As evidenced by Finding of Fact No. 2.j, the Respondent failed to provide two or more service pumps having a total capacity of 2.0 gpm per connection, in violation of 30 TEX. ADMIN. CODE § 290.45(b)(1)(D)(iii) and 290.45(b)(1)(C)(i) and TEX. HEALTH & SAFETY CODE § 341.0315(c).
12. Pursuant to TEX. HEALTH & SAFETY CODE § 341.049(a), the TCEQ has the authority to assess an administrative penalty against the Respondent for violations of state statutes within the TCEQ's jurisdiction, for violations of rules adopted under such statutes, or for violations of orders or permits issued under such statutes.
13. An administrative penalty in the amount of \$8,819 is justified by the facts recited in this Order, and considered in light of the factors set forth in TEX. HEALTH & SAFETY CODE § 341.049(b). The Respondent paid the \$8,819 penalty.

### III. ORDERING PROVISIONS

NOW, THEREFORE, THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY ORDERS that:

1. The Respondent is assessed a penalty as set forth in Conclusion of Law No. 13 for violations of state statutes and rules of the TCEQ. The payment of this penalty and the Respondent's compliance with all the requirements set forth in this Order resolve only the matters set forth by this Order in this action. The Commission shall not be constrained in any manner from requiring corrective actions or penalties for violations that are not raised here. 2. The Respondent shall undertake the following technical requirements:

- a. Within 90 days after the effective date of this Order, obtain an exception from the Executive Director for the use of blended water containing chloramines and water containing free chlorine pursuant to 30 TEX. ADMIN. CODE § 290.39(l), or cease blending, in accordance with 30 TEX. ADMIN. CODE § 290.42. The exception request shall be submitted to:

- b. Within 105 days after the effective date of this Order, submit written certification as described in Ordering Provision No. 2.d below, and include detailed supporting documentation including photographs, receipts, and/or other records to demonstrate compliance with Ordering Provision No. 2.a.
- c. Within 180 days of the effective date of this Order, provide two or more service pumps with a total capacity of at least 2.0 gpm per connection at the Davilla Pressure Plane and Rogers Pressure Plane and at least 0.6 gpm per connection of production capacity at the Wilson Plant Pressure Plane, in accordance with 30 TEX. ADMIN. CODE § 290.45.
- d. Within 195 days after the effective date of this Order, submit written certification, and include detailed supporting documentation including photographs, receipts, and/or other records to demonstrate compliance with Ordering Provision No. 2.c. The certification shall be signed by the Respondent and shall include the following certification language:

"I certify under penalty of law that I have personally examined and am familiar with the information submitted and all attached documents, and that based on my inquiry of those individuals immediately responsible for obtaining the information, I believe that the submitted information is true, accurate and complete. I am aware that there are significant penalties for submitting false information, including the possibility of fines and imprisonment for knowing violations."

3. All relief not expressly granted in this Order is denied.
4. The duties and provisions imposed by this Order shall apply to and be binding upon the Respondent. The Respondent is ordered to give notice of this Order to personnel who maintain day-to-day control over the Facility operations referenced in this Order.
5. The Executive Director may grant an extension of any deadline in this Order or in any plan, report, or other document submitted pursuant to this Order, upon a written and substantiated showing of good cause. All requests for extensions by the Respondent shall be made in writing to the Executive Director. Extensions are not effective until the Respondent receives written approval from the Executive Director. The determination of what constitutes good cause rests solely with the Executive Director. Extension requests shall be sent to the Enforcement Division at the address listed above.
6. The Executive Director may, without further notice or hearing, refer this matter to the Office of the Attorney General of the State of Texas ("OAG") for further enforcement proceedings if the Executive Director determines that the Respondent has not complied with one or more of the terms in this Order.
7. This Order shall terminate five years from its effective date or upon compliance with all the terms and conditions set forth in this Order, whichever is later.
8. This Order, issued by the Commission, shall not be admissible against the Respondent in a civil proceeding, unless the proceeding is brought by the OAG to: (1) enforce the terms of this Order; or (2) pursue violations of a statute within the Commission's jurisdiction, or of a rule adopted or an order or permit issued by the Commission under such a statute.
9. This Order may be executed in separate and multiple counterparts, which together shall constitute a single instrument. Any page of this Order may be copied, scanned, digitized, converted to electronic portable document format ("pdf"), or otherwise reproduced and may be transmitted by digital or electronic transmission, including but not limited to facsimile transmission and electronic mail. Any signature affixed to this Order shall constitute an original signature for all purposes and may be used, filed, substituted, or issued for any purpose for which an original signature could be used. The term "signature" shall include manual signatures and true and accurate reproductions of manual signatures created, executed, endorsed, adopted, or authorized by the person or persons to whom the signatures are attributable. Signatures may be copied or reproduced digitally, electronically, by photocopying, engraving, imprinting, lithographing, electronic mail, facsimile transmission, stamping, or any other means or process which the Executive Director deems acceptable. In this paragraph exclusively,

the terms: electronic transmission, owner, person, writing, and written, shall have the meanings assigned to them under TEX. BUS. ORG. CODE § 1.002.
