Rules Review of 30 Texas Administrative Code Chapter 70

Non-Rule Project No. 2023-101-070-CE

What the adopted action would do:

This action will approve the rules review of Chapter 70, and readopt the chapter.

This action constitutes a determination by the Texas Commission on Environmental Quality, after opportunity for public review and comment, that the initial reasons for adopting the rules of this chapter continue to exist.

Applicable law:

The review of the rules is authorized under the requirements of Texas Government Code, §2001.039; and the General Appropriations Act, Article IX, §9-10.13, 76th Texas Legislature, 1999, which require state agencies to review and consider for readoption each of their rules every four years.

Reason rules are needed:

Executive director's staff conducted a review of the rules in Chapter 70 and determined that the reasons for adopting these rules continue to exist. The rules in Chapter 70 are necessary to implement the commission's enforcement authority under Texas Water Code (TWC), §7.002 of laws within the commission's jurisdiction and to establish the procedures whereby enforcement matters are handled by the commission. The commission is required to adopt rules necessary to carry out its powers and duties under the TWC and other laws of the state, and to adopt reasonable procedural rules to be followed in a commission hearing (TWC, §5.103). The commission is required to adopt rules of practice stating the nature of all available formal and informal procedures (Texas Government Code, §2001.004). The rules also authorize the executive director to pursue an enforcement matter through court action (by referring the matter to the Texas Attorney General), as is contemplated in TWC, §5.230. Subchapter D, Criminal Enforcement Review, is needed to implement the Commission's authority under TWC, §7.203.

This proposal is *limited* to the review in accordance with the requirements of Texas Government Code, \$2001.039, which requires a state agency to review and consider its rules for readoption, readoption with amendments, or repeal every four years. During this review, TCEQ will assess whether the reasons for initially adopting the rules in Chapter 294 continue to exist.

Comments regarding suggested changes to the rules in Chapter 294 may be submitted but will not be considered for rule amendments as part of this review. Any such comments will be considered in a future rulemaking action.

Texas Commission on Environmental Quality Chapter 70 – Enforcement Non-Rule Project No. 2023-101-070-CE

The Texas Commission on Environmental Quality (TCEQ) has completed its Rule Review of 30 Texas Administrative Code (TAC) Chapter 70, Enforcement, as required by Texas Government Code (TGC), §2001.039. TGC, §2001.039, requires a state agency to review and consider for readoption, readoption with amendments, or repeal each of its rules every four years. The commission published its Notice of Intent to Review these rules in the September 22, 2023, issue of the *Texas Register* (48 TexReg 5554).

The review assessed whether the initial reasons for adopting the rules continue to exist and TCEQ has determined that those reasons exist. The rules in Chapter 70 are required because the rules implement TCEQ's enforcement authority under Texas Water Code (TWC), §7.002 of laws within the TCEQ's jurisdiction and to establish the procedures whereby enforcement matters are handled by the TCEQ. TCEQ is required to adopt rules necessary to carry out its powers and duties under the TWC and other laws of the state, and to adopt reasonable procedural rules to be followed in a TCEQ hearing (TWC, §5.103). TCEQ is required to adopt rules of practice stating the nature of all available formal and informal procedures (Texas Government Code, §2001.004). The rules also authorize the executive director to pursue an enforcement matter through court action (by referring the matter to the Texas Attorney General), as is contemplated in TWC, §5.230. Subchapter D, Criminal Enforcement Review, is needed to implement the Commission's authority under TWC, §7.203.

Public Comment

The public comment period closed on October 23, 2023. TCEQ did not receive comments on the rules review of this chapter.

As a result of the review TCEQ finds that the reasons for adopting the rules in 30 TAC Chapter 70 continue to exist and readopts these sections in accordance with the requirements of TGC, §2001.039.

ORDER ADOPTING RULES REVIEW AND READOPTING RULES

On March 28, 2024, the Texas Commission on Environmental Quality (Commission) approved the rules review of 30 Texas Administrative Code (TAC) Chapter 70, Enforcement in accordance with the requirements of Texas Government Code, § 2001.039, which requires a state agency to review and consider for readoption each of its rules every four years. The proposed Notice of Intention to Review was published in the September 22, 2023, issue of the *Texas Register* (48 TexReg 5554).
