COMMENTS: I am the Director of Hope House, a special needs home located less than 2800 feet from the proposed site. I am requesting a contested case hearing, specifically based on the letter attached from medical personnel. I will continue to update my comments as we move forward.

Dear TCEQ,

I'm writing as a concerned medical professional advocating for the special needs community of Liberty Hill. I currently work as the registered nurse at Hope House. Hope House is a 501c3 nonprofit service organization that has been providing a long-term home with care and support to children and adults with profound mental and physical disabilities throughout Central Texas for 55 years.

Wilco Aggregates is seeking to build a rock crushing facility on CR 284 in Liberty Hill. This facility will be located approximately 300 yards from Hope House's main campus which houses our youngest residents. My primary concern with the rock crushing facility is the negative impact on air quality with the amount of particulate matter (PM) that will infiltrate the surrounding area, not to mention the PM coming from trucks transporting material to and from the facility that could potentially drive on the road right next to our kids' playground.

Poor air quality is known to affect the healthiest of individuals and can cause life long respiratory issues. Here at Hope House, we frequently care for children who have compromised respiratory systems. I hate to imagine what we might be dealing with should the rock crushing facility come to fruition. I urge you to reconsider the location of the rock crushing facility.
