## Good morning,

Rep. Vasut would appreciate if each of you would consider sending a similar letter (attached) to Chief Clerk Gharis with TCEQ in opposition to Permit No. WQ0016046001 for Undine Texas Environmental LLC. This is for the discharge of up to 250,000 gallons of treated effluent per day from this project and will materially impair the use of Bastrop Bayou for fishing, recreation, and drainage. A greater discharge upstream will naturally result in an increase in silting downstream. The lower reaches of the bayou have already experienced substantial silting, which has impaired fishing, recreation and drainage in the area. The bayou is also a delicate eco-system, fluctuating between fresh and brackish water. An increase in the discharge of fresh water upstream threatens to disrupt that delicate balance in salinity. The off shoot of the watershed go into SD 11 and Rep. Thompson will have the lower Bastrop Bayou section starting in January 2023.

Rep. Vasut requested and was granted by Executive Director Tobey Baker a Public Meeting held on July 28, 2022 and over 250 residents attended that meeting. There was also opposition from the entire Brazoria County Commissioner's Court, city mayor's, and the CCA.
