Re: Application by Harris County Municipal Utility District No. 542 (Applicant) for Major Amendment of TPDES Permit No. WQ0015312001; TCEQ Docket No. 2023-0280-MWD.

The above-named matter is scheduled to be considered by the Texas Commission on Environmental Quality (Commission) at its March 31, 2023 public meeting. Responses from the Executive Director, Office of Public Interest Counsel, and Applicant to hearing requests were due on March 8, 2023. TCEQ's Office of the Chief Clerk received timely responses from the Executive Director and the Office of Public Interest Counsel.

On March 14, 2023, the Executive Director submitted a Supplemental Filing to her Response to Hearing Request. The Executive Director indicates that the Supplemental Filing addresses an error in the GPS map attached to her timely-filed Response to Hearing Requests.

Although the Executive Director's Supplemental Filing is untimely under TCEQ rule 30 TAC § 1.10, the Executive Director indicates that it is being filed to correct an error and shows the correct location of the hearing requester's property. Accordingly, pursuant to 30 TAC § 1.10(h), the General Counsel extends the filing deadline for the Executive Director's response until March 14, 2023. In addition, the deadline for the hearing requester to file a reply is extended to 5:00 p.m. on March 24, 2023.
