GCC Sun City Materials submitted an application on April 9, 2021 to the Texas Commission on Environmental Quality (TCEQ) for the renewal of Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0004636000, which authorizes the disposal of wastewater treatment plant sewage sludge and water treatment plant residuals 142 acres. On May 10, 2022, the TCEQ published a notice of application and preliminary decision for disposal of sewage sludge and water treatment plant residuals permit for GCC Sun City Materials application.

There is substantial public concern regarding the proposed renewal of the permit, which would authorize the continued operation of the GCC Sun City Materials in my district. Therefore, I am formally requesting a public meeting at the Fire Rescue Building located in 5541 US Highway 62/180, Desert Haven, Texas, 79838, so the TCEQ and the applicant can explain the application and provide the community an opportunity to be heard and continue to voice their concerns.
