We request a contested case hearing.

As an adjoining landowner we are clearly an "affected person" there is no question that our land is currently being adversely affected and possibly more severely adversely affected in the future if this permit moves forward without assurances to the contrary.

We were very disappointed that not all our questions within the public comments were not completely answered within the RTC with one response being false. **The fact that these responses are incomplete does not allow me to determine the level of impact or uses of my property in the future.**

The response to questions being disputed are as follows:

Response 14, did not address the plan to convert the inactive portion of the 310-acre site from cultivated ground to permanent grass.

Response 15, did not answer if berms and fences will be built around the entire 310-acre site before any dumping occurs.

Response 16, attachments one and two are false. Also the application states a "small creek" that is now referred to as a "water course". If it is now a "water course" please remove any and all designations of "small creek" from the application or any documentations.

Response 17, only refers to active site of monofil and does not address the inactive portion of the site.

It is unfortunate that due to the negligence of the NTMWD, we have no confidence at this time that the river of silt running onto our property from the 310-acre NTMWD site will stop now or in the future. Our concern is after activity begins more storm water/silt will be channeled onto our property. Please note, I met with the NTMWD in January 2022 and discussed this very issue, shockingly no effort has been made to eliminate this issue or make known a detailed storm water/silt plan for present and future.

We truly believe a contested case hearing is our only option at this time. If we could get written detailed plan that provides assurance that the issue will be addressed now and, in the future, at that time we would be happy to withdraw our request.

Anyone can look at an aerial photo of the proposed site and clearly see the erosion issues on the site. Obviously, the damage is much worse if you are on site.

As an adjoining landowner I know all too well the damage created by tons of silt carried from this site to my property. Such as burying fences with four to five feet of silt, killing trees from being covered with silt and my personal favorite stuck livestock.

There are many questions that need to be answered before this application moves forward. That's why I am requesting multiple public meetings and a contested case hearing.

Following are a few questions top of mind:

- Has anyone from the TCEQ physically visited the proposed site? If so, when?
- Has the TCEQ received an application for dumping water treatment residual on a site of this size (310 acres)?
- What is the largest site, prior to this site, in which an application has been made for dumping water treatment residuals?
- What is the largest site ever approved by the TCEQ for dumping water treatment residuals?

- This permit allows processing on site but does not allow discharge of contaminated water. How will the contaminated water be dealt with?
- In the future does the TCEQ expect the NTMWD to apply for a discharge permit which would allow discharge of contaminated water into the flood plain?
- What is the plan to eliminate silt runoff onto neighboring properties and into creeks, rivers, and reservoirs?
- Will the Soil Conservation Service be involved in the planning and ensure all silt will be contained to the site? If not, who?
- What is the plan to convert the inactive portion from cultivated ground into a permanent grass?
- Will an independent, certified agronomist be involved in this transformation into grass, and will standard practices be used to establish a healthy stand which includes annual fertilization, regular herbicide application and frequent mowing?
- Will berms be built around the entire site before any dumping occurs?
- Will a fence be built around the entire site before any dumping occurs?
- Within the Attachment M of the application under East Parcel, please identify the "small creek at the eastern edge of the parcel". I am unaware of any small creek on my western edge of my property which I have owned for over 40 years.
- Will there be a series of retention/settling ponds to slow the velocity of runoff water as it exists onto neighboring properties and hopefully eliminate washouts and silt entering creeks, rivers, and reservoirs?
- What is the proposed route of the pipeline from Wylie to the site and what size pipe will be used?
- Will any form of Eminent Domain be used to acquire any part of the pipeline right of way?
- Will this facility operate 24 hours a day or will be limited hours of operation?
- This application has asked for an increase to 100,000 tons deposited annually, this is roughly 2,000 tons per week, where will these truck loads originate from and how many truck loads per day can be expected?
- What is the estimated total cost of this project when completed?

In closing, these are just a few of my questions I hope will be answered. Obviously, answers to these questions will create many more questions.

There is no doubt this proposal affects many landowners and individuals far beyond a one-mile radius of this site. I see no way this application should move forward without multiple public meetings and a contested case hearing.

COMMENTS: I respectfully request a public hearing regarding the proposed sludge monofill permit # WQ0005323000 to discuss a number of concerns including those I've outlined below. My family and I live directly to the south of the bulk of the land where this proposed monofill would be located. We operate a commercial cut flower farm along with an apiary, swine, and poultry which we raise for both personal and commercial use. I have significant concerns regarding the environmental and health impact of the proposed monofill, especially given the proximity of my family's home directly

adjacent to the proposed site. I am concerned regarding potential harm to farm production and our on-farm retail operation -- there are other similar small-scale farms nearby including a dairy operation that will also face negative consequences from this proposed monofill. The increase in truck traffic (both during construction and on an ongoing basis) on a residential road with a number of children and domesticated animals living near the proposed site is also of major concern. I also have significant concern regarding the likely reduction in marketable value for nearby properties and the general nuisance this will represent to those of us unlucky enough to live in close proximity to the site.

I had identified that NTMWD had purchased two adjacent properties to my new home from Glynn Dodson, who subsequently has farmed them for many years. I finally got a return call after days/weeks of trying to contact NTMWD, to understand what their intent was with the properties. "RJ" NTMWD returned my call and I asked the specifics, his response was "we will never use them unless

our present technology of disposal of waste changes, and if we do we will will put a maintenance facility on the acreage adjacent to your home". Needless to say I wasn't 100% sold on the response, but I did end up buying the property. I recently had a discussion with the City of Josephine, who indicated that prior to my discussion NTMWD had already reached out to them as "good neighbors" who indicated their intent to use the property for waste disposal. So I am trying to rationalize the statement from NTMWD of "if our current technology changes" to what appears they clearly had intent to use the properties. SO WHAT CHANGED IS THE QUESTION. The answer is nothing, they always had the intent. And I question the response and truthfulness of what was relayed to me in November of 2016, it was an unethical response. But what has changed is there is now (since they purchased to the time they signaled intent) a growing community of residents, new dairy production, new apiary sites and most import land development surrounding the proposed site. COMMENTS: I received a notice today that the North Texas Municipal Water District is no longer seeking a permit for Biosolid Surface Disposal, but rather is now seeking a permit for Water Treatment Residual Disposal. My understanding is that these are both the same thing, but a permitting process by the latter name does not exit. I am very concerned, as I live in a residential property that is right next to the site for which this permit is being sought. According to guidelines set by the Texas Commission on Environmental Quality, this permit should not be issued because the application

submitted by the North Texas Municipal Water District does not meet the bare minimum requirements for such a facility as is currently being proposed. The applicant is required to define what barrier they will utilize to prevent seepage - NTMWD plans to use compacted clay. Everyone who lives here knows that crawdads are going to tunnel straight through that. The applicant already lied to the commission on Environmental Quality on the disposal rate on their initial application. According to their statements at Josephine City Hall in November 2021, they plan to truck over approximately 700,000 gallons of Biosolids, Water Treatment Residuals, every Day. This would be 60 Tanker trucks a day on a road that isn't meant to support that type of traffic. The science is still out on what will happen if the coagulants and heavy metals found in Water Treatment Residuals can have an impact on livestock (there are cattle and goats being raised in property connecting to the property for which they are seeking a permit). There has been no discussion on what will be done to prevent this from impacting the ground-water in the area or what will be done to off-set the pollution of the tanker trucks until a pipeline can be built from their plant to this site. I will be in touch with local news outlets and our state representatives if this permit is approved. Please let me know when the hearing will be scheduled. I would love have answers from the applicant on why they omitted so many answers on their application, and what caused the changes, and to probe to see if there is anything else they may choose to change. During the meeting at Town Hall, they were condescending, and insulting to residents who had serious questions.
