EXECUTIVE DIRECTOR'S REPLY TO PROTESTANTS EXCEPTIONS TO THE ADMINISTRATIVE LAW JUDGE'S PROPOSAL FOR DECISION

The Executive Director of the Texas Commission on Environmental Quality (TCEQ or Commission) maintains her position that the draft permit meets the requirements of the applicable statutory and regulatory requirements and will be protective of human health and the environment. Ellis County, the City of Midlothian, and the City of Waxahachie continue to reargue issues that were thoroughly vetted during the hearing.

The Executive Director supports the Administrative Law Judge's (ALJs) conclusions that Highland Lakes Midlothian I LLC has met its burden of proof on all five agreed issues², and the draft permit be issued without changes.³ Therefore, the Executive Director respectfully requests that the Commission adopt the ALJ's proposed order with the Executive Director's recommended changes presented in her Exceptions to the PFD and issue the proposed permit.
