# MOTION FOR LEAVE REGARDING RESPONSE TO HEARING REQUESTS

In a letter in the above referenced docket dated September 20, 2023, the Chief Clerk of the Texas Commission on Environmental Quality ("*TCEQ*") notified interested parties that the above referenced matter will be considered by the TCEQ Commissioners on October 25, 2023. The Chief Clerk's letter provides an opportunity for certain parties to file written responses to hearing requests by October 2, 2023. Filing instructions in the Chief Clerk's letter identify the TCEQ's eFiling System as a method to file such responses, which note that documents must be submitted by the close of business (5 p.m. CST) unless otherwise specified.

Responses filed by Cipriani Island Laguna Azure, LLC and Megatel Homes, LLC (collectively "Cipriani") were filed using the TCEQ's eFiling System. However, due to unanticipated logistical and technical issues, Cipriani's briefing regarding the hearing requests was received by TCEQ at 5:24 p.m. on October 2, 2023, and various other exhibits were filed less than 90 minutes later. All documents filed were served on the interested persons on the mailing list included with the Chief Clerk's letter shortly thereafter. In addition, other backup documents were filed by the TCEQ Executive Director on October 6, 2023 which are relevant to filings by the parties and for consideration Commission consideration.

Pursuant to TCEQ's rules at 30 Tex. Admin. Code §1.10(g), the Commission may choose

not to consider documents which have not been filed in strict compliance with TCEQ's filing

procedures. Pursuant to TCEQ's rules at 1 Tex. Admin. Code §1.10(h), the Commission or general

counsel may waive one or more filing requirements, and pursuant to 10 Tex. Admin. Code §10.3

the general counsel by agreement of the interested persons or on the general counsel's own motion

may extend a filing deadline. To the extent the Commission may chose not to consider the

documents filed by Cipriani after 5 p.m. on October 2, 2023, Cipriani requests leave so that such

documents will be considered by the Commission. Cipriani does not believe that any interested

person would be prejudiced since interested parties have until October 16, 2023 to file responses,

and Cipriani's filings were filed and served within a very short timeframe after 5 p.m. on the due

date.

On October 3, 2023, Cipriani contacted counsel for the TCEQ Executive Director, counsel

for the TCEQ Office of Public Interest Counsel, counsel for the City of Mansfield ("City"), and

counsel for Johnson County Special Utility District ("JCSUD"), which includes all of the

interested parties on the mailing list attached to the Chief Clerk's letter. Counsel for the TCEQ

Executive Director and counsel for OPIC responded on the same day that they do not object to a

motion for leave to address Cipriani's documents which were filed past 5 p.m. on October 2, 2023.

Cipriani contacted counsel for the City again on October 9, 2023, and on October 10, 2023 counsel

for the City responded that the City would object to a motion for leave. Although the City could

have filed its own objections, the City has chosen not to do so. Cipriani contacted counsel for

Johnson County Special Utility District again on October 10, 2023, but no response has been

received regarding JCSUD's position on a motion for leave.

MOTION FOR LEAVE TCEO DOCKET NO. 2023-0845-DIS

If the Commission or the general counsel is inclined not to consider Cipriani's documents filed after 5 p.m. on October 2, 2023, and if the general counsel or the Commission determines not to expressly grant leave to Cipriani for its unintentional filing errors, Cipriani requests that the above referenced matter be continued and considered by the Commissioners at the next available date.
