**APPLICANT MEGATEL HOMES, LLC’S  
EXCEPTIONS TO THE PROPOSAL FOR DECISION AND PROPOSED ORDER**

Megatel Homes, LLC (“*Megatel*”) files the following Exceptions to the Proposal for Decision (“*PFD*”) and Proposed Order filed by the Administrative Law Judge (“*ALJ*”) on November 22, 2024. Megatel agrees with the ALJ’s reasoning, analysis and conclusions in the PFD which is fully supported by the evidentiary record, and requests only the following clarifications to the ALJ’s Proposed Order:

Findings of Fact:

25. Neither the City nor the Trinity River Authority (TRA) [TRA] are designated regional providers, and no regional provider has been designated for the proposed territory of the Cipriani Development to be served by the Facility.
34. The City has a contract with TRA [~~the Trinity River Authority (TRA)~~], under which the City transports wastewater to TRA’s Mountain Creek Regional Wastewater System for treatment. Under the City’s contract with TRA, the City is to provide service to the area that includes the Cipriani Development.

Ordering Provisions:

2. Applicant and the City must each pay 50% of the transcription costs, which total \$3,363.50. The City is ordered to pay to Applicant \$1,681.62.
