COMMENTS: The Collin County Soil & Water Conservation District #535 is considered the owner of FWRS Site 8f, EFAL, that this facility plans to discharge treated wastewater in to. We were not formally notified of this permit application, however two landowners around the dam contacted us. The SWCD has great concerns about this plan. Site 8f was designed and constructed as a low-hazard floodwater retarding structure in rural agricultural land. It was not designed for and cannot handle this type of additional flow, especially in wet seasons, as planned in this application. The principal outlet pipe of this structure in only 12 inches in diameter and often becomes clogged with debris or from beaver damage. The additional discharge planned for in this permit will potentially cause extensive damage to this structure by either causing the auxiliary spillway to function more often or by over-topping the dam. There is already some erosion in the spillway outlet, and additional flow will only make this worse. As sponsor and owner of this dam, the SWCD does not have the funds for these kinds of repairs nor does the SWCD have funds to upgrade the dam at this time. Additional flow into the unnamed tributary just upstream of this dam will most likely add additional sediment from stream channel erosion to the structure, also. The SWCD would ask that an alternative route be considered that would not outlet into any channel directly upstream of any flood control dam in the county. At the very least, we would ask for plans that could detain discharge water during rainy seasons and flood events. The SWCD would ask that they be notified of any future application, such as this, that would directly impact a dam we are responsible for. Please keep us informed of the status of this application and notify us if a public meeting or contested case hearing are being scheduled.

We were not formally notified of this permit application, however two landowners around the dam contacted us. The SWCD has great concerns about this plan. Site 8f was designed and constructed as a low-hazard floodwater retarding structure in rural agricultural land. It was not designed for and cannot handle this type of additional flow, especially in wet seasons, as planned in this application. The principal outlet pipe of this structure in only 12 inches in diameter and often becomes clogged with debris or from beaver damage. The additional discharge planned for in this permit will potentially cause extensive damage to this structure by either causing the auxiliary spillway to function more often or by over-topping the dam. There is already some erosion in the spillway outlet, and additional flow will only make this worse. As sponsor and owner of this dam, the SWCD does not have the funds for these kinds of repairs nor does the SWCD have funds to upgrade the dam at this time. Additional flow into the unnamed tributary just upstream of this dam will most likely add additional sediment from stream channel erosion to the structure, also. The SWCD would ask that an alternative route be considered that would not outlet into any channel directly upstream of any flood control dam in the county. Our property will be adversely effected by allowing up to 200,000 gallons of discharge water to be released per day. A large reservoir borders our property to the west, this reservoir frequently floods a 2 acre area of our property depending on weather conditions. The flooding has lasted 4-6 months at a time in the past. When this occurs we do not have access to a large area of our property. The natural flooding that occurs will be magnified with 200,000 additional gallons of discharge

water that would be released daily. I feel this would compound the negative impact to our property making it inaccessible for extended periods of time or perhaps permanently.
