Dear Chief Clerk,

On behalf of the Plum Creek Watershed Partnership, I am sharing our chief concerns with the draft permit to discharge waste by Greenwood Ventures Group LLC.

The Plum Creek Watershed Partnership, established in 2006, works to implement the Plum Creek Watershed Protection Plan, which was approved by the US EPA in 2008 and continues to be funded through the Texas State Soil and Water Conservation Board and supported by its 12 local funding partners. As the first Watershed Protection Plan to be approved in the state of Texas, TCEQ provided technical support and was involved in the early development of this WPP with all the other stakeholder groups.

West Fork Plum Creek, which is the receiving body for the applicant's effluent, drains directly to Plum Creek which has been impaired for *E. coli* bacteria since 2004. Additionally, as of the 2022 *Texas Integrated Report* published by TCEQ, Plum Creek also has concerns for Nitrate Nitrogen, Ammonia Nitrogen, Total Phosphorus, impaired macrobenthic community, impaired fish community, impaired habitat, and fish kill in water.

Since 2008, the Watershed Protection Plan (WPP) and the Plum Creek Watershed Partnership have recommended that all wastewater effluent be treated to the "5/5/2/1" standard. The 5/5/2/1 is 5 mg/L Carbonaceous Biochemical Oxygen Demand, 5 mg/L Total Suspended Solids, 2 mg/L Ammonia Nitrogen, and 1 mg/L Total Phosphorus. Permit limitations above that of the 5/5/2/1 will further degrade water quality that this organization and its stakeholders work so hard towards improving.

The applicant seeks to discharge while operating under a 10/15/2/1, that is 10 mg/L Carbonaceous Biochemical Oxygen Demand, 15 mg/L Total Suspended Solids, 2 mg/L Ammonia Nitrogen, 1 mg/L Total Phosphorus.

While the Ammonia Nitrogen and Total Phosphorus limitation is consistent with our recommendation, we advise that the draft discharge limits be amended to reduce the impact to water quality within West Fork Plum Creek and the Plum Creek Watershed.

We respectfully request that the Texas Commission on Environmental Quality consider the continual work of the Plum Creek Watershed Partnership, the recommendations of our WPP for the 5/5/2/1 permit parameters, and the state of the entire watershed when reviewing this draft permit.

Dear Sir or Madam,



My name is Jason O'Keefe and I live at 2516 Mineral Springs Road which is SE of the proposed treatment plant property. My property shares the fence line with that property and the proposed plant site is less than a mile from my residence. I am here speaking to you today to state that I am against this application and hope that TCEQ denies the permit.

One of my concerns lies with the West Fork stream, right behind my property, that this application pertains to, (which leads right into Plum Creek Watershed). Plum Creek has sustained very large changes in population over the past 1-2 decades, and thus needs to not have another point of entry of wastewater from yet another ridiculously large subdivision. Plum Creek has had a history of nutrient concerns and bacteria impairment, as stated in the Plum Creek Watershed Protection Plan created by the Plum Creek Watershed Partnership; circa 2008. With all the rapid growth already occurring from upstream cities such as Kyle and Buda, TCEQ needs to restrict the wastewater discharge access to this sensitive watershed, and deny the use of the Clear Fork stream as a point of discharge.

Another concern I have is with the process TCEQ grants permits for wastewater plants. Neither the wastewater treatment plant type nor the 3rd party treatment plant operator, (who will manage the treatment plant thereafter), have been declared before the permit is granted. This is a "putting the cart before the horse" process, in my opinion. When building my new home, TCEQ via the Caldwell County Sanitation Department required me to have my site evaluated for the system type necessary and provide the licensed company who would install the required system before my permit was approved. I then was required to have a licensed septic maintenance provider check and maintain the system after the system was installed. This process of permitting without defined parameters before the permit approval is backwards compared to individual home owner requirements. For larger facilities, the criteria for limits and design should be similar or even higher than that of the individual home owner's wastewater treatment system.

The lack of TCEQ oversight of the 3rd party management company is low, but still another one of my concerns. This lack of oversight and regular monitoring of plant maintenance could result in a large-scale catastrophe. Plum Creek cannot afford a large catastrophic event in which tens of thousands of gallons of raw or under-treated sewage is accidentally dumped into the Plum Creek watershed via the West Fork stream because of negligence or poor management of a 3rd party operator or lack of oversight by TCEQ. This has happened before; citing the Porter Creek Tributary in 2000-2001, where "sewage bypass occurred as a result of excessive sludge buildup, which was eventually released to the stream causing extremely high bacteria concentrations directly downstream of the discharge point". This quote and note on historical information have been taken from the Plum Creek Watershed Protection Plan.

Lastly, the 10/15/2 requirements for monthly average levels for effluent discharge make-up, seem to be lenient versus the 5/5/2 or 5/5/3 that other local watershed authorities have instated. For those in the audience, this is the biochemical oxygen demand (BOD), total suspended solids (TSS) and ammonia levels, all in mg/L. With proven, feasible, and in use higher standards in place and being followed by numerous other local wastewater districts, TCEQ should raise their standards and reduce the solids/chemical makeup output to the 5/5/2 level on all permits. This just makes sense to reduce even further the solid waste particulate and chemical content of all treated wastewater into our streams and

tributaries. Why this standard has not been implemented already further pushes my belief that this agency is lacking resources for optimization, follow-up procedures and regulatory protocols. And with these problems, I foresee a possible catastrophic environmental failure with this proposed plant and many others, in the future.

In closing, these accumulated concerns, in whole, further emphasize my rejection of this permit for Plum Creek, and ask that TCEQ <u>deny the wastewater permit to Greenwood Ventures Group LLC</u>.

My name is Jason O'Keefe, and my family and I live at 2516 Mineral Springs Road. I share a property line with this property and my house is +/- 1 mile from the proposed treatment plant. As a close-proximity neighbor, I have concerns with having this treatment plant next to my ranch and my neighbors' ranches. I understand the need for such a plant and understand the positive environmental benefits and needs of having such facilities. We, as the human race, have to find ways to treat waste and, at the same time, not destroy ecosystems, contaminate ground and surface water sources, and be general good stewards to our planet. With this being stated, my concerns lie with primarily with the following:


- 1. Plant facility type.
- 2. Plant management company and their seriousness in proper maintenance and accident prevention.
- 3. TCEQ and EPA oversight of the plant and making sure the plant is following proper protocol and procedures, during the build and thereafter.
- 4. Odor-eliminating measures to ensure air quality for everyone around the plant.

Plant facility-type is to be determined after the permit process, to my understanding, so we do not know what type of sewage treatment plant will be built. Each type of system, based on my research, all must address and manage flammable and deadly gases, (such as Methane and Hydrogen Sulfide), proper facility design and maintenance, and redundant safety measures to prevent and capture accidental discharge, etc. There are positives and negatives to each type of plant; knowing which type would possibly ease these concerns I have.

It is important to know who/what company will manage and operate this treatment plant once it is in full operation. Making sure that this company properly maintains this plant, hires competent, trained personnel, and goes above and beyond all safety measures, is very important. As neighbors, our properties, our lives, and our wildlife/livestock are the ones that would be detrimentally affected by any accident from this plant, due to any lack of quality in these key points mentioned.

Oversight and regular facility checks, in my honest opinion, will be extremely important to the success of this treatment plant and to anyone that it could negatively affect during the course of a major accident. I understand that the TCEQ will monitor wastewater discharge, but will it do regular site visits, leak checks, containment vessel checks, etc.? There seems to be a trend going on with the lack of skilled personnel, lack of resources, and lack of funding, from a broad spectrum of Government organizations. We, as the neighbors of this treatment plant, need assurances that these problems will not creep into the workings of the TCEQ and find their way down into this, or any other regulation of wastewater treatments plants.

Lastly, but still important, is the air quality around this wastewater treatment plant. I understand that no one likes an odor-emitting facility in their backyard. However, there is more to it than just the foul odor. With said odor comes a possibility of a higher level of particulate that can be detrimental to anything that breathes in that air. It is important to have odor-eliminating measures in place, as such measures will also prevent accidental release of over-saturated low-quality or even toxic air, into the atmosphere and surrounding area. Air quality monitoring would also help in warning and preventing a catastrophic fire or explosion from flammable gases, such as wet have.



In conclusion, all neighbors of such a facility need to be assured that if this permit passes, that all safety measures are in place, stringently adhered to, and are constantly being reviewed by the governing bodies. Please take my concerns, along with everyone else's, into account when deciding on this permit.

Caldwell County development staff have received no submittals or other information regarding the proposed development referenced in this application. This site has significant constraints and issues related to floodplain, access, transportation plan compliance, water availability, land use compatibility, and water quality. The proposed discharge watercourse is the west branch of Plum Creek. This creek has a large watershed area and is prone to frequent flooding. No engineering

information has been provided to Caldwell County demonstrating that development of this tract is feasible due to wide and deep floodplain areas. Access to the site is via one small County Road (CR 215). In addition to a large required and probably non feasible bridge span over the floodplain, the development of the site will require a TIA and significant roadway improvements. In addition to access and floodplain issues, no information has been provided demonstrating that adequate potable water is available to the subject property. Large water lines with available capacity are not available in the area. As Caldwell Commissioner for this area, I oppose the issuance of this permit until such time that adequate information is provided to the County demonstrating that the above-mentioned site constraints can be mitigated and that the project can comply with all County development regulations.
