Dear Chief Clerk:

Williamson County Water, Sewer, Irrigation, and Drainage District No. 3 ("<u>WSIDD3</u>") files this reply to the Response to Requests for Hearing and Request for Reconsideration (the "<u>Response</u>") filed by Preserve Hutto, LLC (the "<u>Applicant</u>").

The Applicant, in its Response, declines to take a position on whether the WSIDD3 "board has satisfied the procedural and substantive requirements prerequisite of the granting of a hearing." WSIDD3 instead concurs with the responses of the Texas Commission on Environmental Quality (the "*TCEQ*" or "*Commission*") Executive Director and Office of Public Interest Counsel that WSIDD3 qualifies as, and is, an affected person.

The Applicant also disputes all issues raised in the hearing requests, and asserts that none of the issues support referral to the State Office of Administrative Hearings ("<u>SOAH</u>") for a contested case hearing. WSIDD3 is not obligated to reply in order to reaffirm its position on the issues it raised. WSIDD3 nevertheless states here on the record that it disagrees with the Applicant regarding the issues raised by WSIDD3. WSIDD3 concurs with the Executive Director and Office of Public Interest Counsel that WSIDD3 raises disputed issues of fact; that those issues are relevant and material to the Commission's decision on the Application; and that those issues are appropriate for referral to SOAH.
