Re: Motion to Overturn the Executive Director's Amendment of Certificate of Adjudication No. 14-5434 (Amendment No. 14-5434G) held by the Lower Colorado River Authority (LCRA); TCEQ Docket No. 2024-0078-WR.

The Texas Commission on Environmental Quality (Commission) will consider a Motion to Overturn (MTO) filed by Garwood Irrigation Company, LLC (Movant) pertaining to the Executive Director's December 21, 2023, issuance of an amendment to LCRA's Certificate of Adjudication No. 14-5434. The Amendment is designated as Certificate of Adjudication No. 14-5434G.

The Commission will consider the MTO; timely responses from the Executive Director, Office of Public Interest Counsel, and LCRA; and the Movant's reply at the Commission's public meeting scheduled to begin at **9:30 A.M. on Wednesday, March 6, 2024, in Room 201S, Building E, 12100 Park 35 Circle, Austin, Texas 78753**. The meeting may be held in person, virtually, or both in person and virtually. The Commission will take oral argument on this matter during the public meeting. The Movant or their representative may speak first and save part of their time for rebuttal. The Movant will have five minutes of oral argument time. The Movant will be followed by LCRA, who will have five minutes of oral argument time. The Executive Director will speak next, followed by the Office of Public Interest Counsel. The Executive Director and the Office of Public Interest Counsel will each have five minutes for their respective oral presentations.
