On behalf of all Godley residents, we appreciate the TCEQ's holding of a public meeting on September 19, 2023 to discuss the referenced permit application.

Many residents did come out in opposition to the permit application on September 19th. However, it soon became evident that the required public notices of the application and public meeting did not fully comply with the TCEQ's rules and procedures. Clear deficiencies existed throughout the successive series of mailed and published notices (including alternative language). As such, additional affected property owners and interested persons were not timely and properly made aware of this project, preventing them from submitting public comments to TCEQ.

Ladies and Gentlemen:

The proposed Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0016202001 would affect a number of residents and landowners within House District 58 and Senate District 10. Some of those landowners in the immediate vicinity of the System have expressed serious concerns over the effects of the System on their lands and waters. This raises questions such as impacts upon existing uses of the receiving waters, the need for a more comprehensive antidegradation review, and the impact on recreational uses of the Nolan River. All potentially harmful impacts that the proposed System may have on the community, as well as individuals' concerns, should be thoroughly vetted, and the voices of affected landowners should be properly considered before TCEQ makes a decision whether to issue the permit.

We therefore respectfully request a public meeting for the benefit of current and future residents of Johnson County and the State of Texas. Public meetings are critical for hearing all sides. The robust participation of the public - affected landowners and others - helps ensure that as Texas grows, it does so with respect for its existing residents and the natural resources of the state.

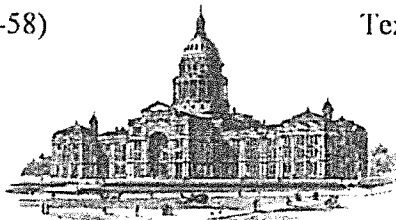
