EXECUTIVE DIRECTOR'S EXCEPTIONS TO THE ADMINISTRATIVE LAW JUDGE'S PROPOSAL FOR DECISION

I. OVERVIEW

The Executive Director of the Texas Commission on Environmental Quality (TCEQ or Commission) submits her Exceptions to the Proposal for Decision. The Executive Director supports the Administrative Law Judge's (ALJ's) conclusion that Mr. Mewis' application should be denied. The Executive Director is providing suggested changes to the Findings of Fact.

II. EXCEPTIONS to the PROPOSAL for DECISION

A. Executive Director's Recommended Changes to Findings of Fact

The Executive Director recommends the following change to the ALJ's Findings of Fact:

1. Finding of Fact #4 (Correction/Clarification)

Finding of Fact #4 states the ED referred the case to the State Office of Administrative Hearings (SOAH) on July 1, 2024. The Executive Director notes that the ED referred this case to SOAH on June 4, 2024.

2. Finding of Fact #9 (Correction/Clarification)

Finding of Fact #9 states that on October 25, 2005, Mr. Mewis was convicted of forgery of a financial instrument. The ED notes that on October 24, 2005, Mr. Mewis was convicted of forgery of a financial instrument.²

3. Finding of Fact #13 (Correction/Clarification)

Finding of Fact #13 states that on November 11, 2016, Mr. Mewis was convicted of tampering and fabricating physical evidence. The ED notes that on November 15, 2016, Mr. Mewis was convicted of tampering and fabricating physical evidence.³

III. Conclusion

The Executive Director maintains her position that Mr. Mewis' application should be denied. The ED respectfully recommends the Commission adopt the ED's suggested corrections to the findings of fact noted above.
