On December 12, 2022, Argos USA LLC (Argos), applied for the renewal of Air Quality Standard Permit, Registration No. 105998, which would renew Standard Permit, Registration No. 170945, which would authorize continued operation of the Concrete Batch Plants located at 302 Bennington Street, Houston, Harris County, Texas 77022. PCS submits the following comments in response to the opportunity for public comment.

PCS inspects facilities in Harris County for compliance with air quality laws and regulations, reviews permit applications, and comments to the TCEQ on permitting actions. PCS also works closely with the TCEQ's Houston regional office which, as a matter of course, refers a substantial portion of environmental complaints, including nuisance complaints, from Harris County citizens to PCS. PCS then investigates these complaints and, when appropriate, issues Violation Notices and refers cases to the Harris County Attorney's Office or District Attorney's Office for civil or criminal enforcement.

PCS is concerned that Argos' operations at the proposed site have the potential to cause nuisance dust conditions near the facility. Based on the area map, the facility is located directly west and south of a densely populated residential neighborhood.

To minimize the potential impact of particulate matter (PM) emissions from this facility, PCS recommends that the facility adopt the following control measures based on those found in the Air Quality Standard Permit for Concrete Batch Plants with Enhanced Controls.

- (3)(B)(i) Ensure that the fabric/cartridge filter systems and suction shroud are operated properly with no tears or leaks
- (3)(E) Pave each road, parking lot, or other areas at the plant site that are used by vehicles with a cohesive hard surface and properly maintain, clean, and water to minimize dust emissions
- (3)(K)(ii) Keep stationary equipment, stockpiles, and vehicles used at the plant, except for incidental traffic and vehicles as they enter and exit the site, located, or operated more than 100 feet from any property line
- (3)(L)(i) Install a 12-foot high, dust suppressing barrier as a border around roads, traffic areas, and work areas
- (3)(L)(ii) Place three-walled bunkers around all stockpiles that are at least two feet above the top of the stockpile

PCS also recommends that the facility adopt the following control measures and work practices:

- Cover stockpiles when not in use to minimize dust emissions
- Maintain a vegetative barrier (trees and other foliage) around as much of the perimeter of the facility as possible
- Install a wheel wash and rumble strips at the exit of the facility to prevent tracking concrete onto the roadway
- Operate only during daylight hours





We along with the other 5000 + other residents in the vicinity are in opposition of the Air Quality Permit for the continued operation of the Argos USA LLC facility located at 302 Bennington St. Houston, Harris County, TX 77022.

It is also highly likely that the ARGOS November 22, 2022 event showed up on AirTracker!

Initial data gathering by Environmental Defense Fund Texas (EDF-TX) shows an air monitor on the Air Tracker network registering up to 17 ug/m3 between 11:30 and 1:30 when the wind was blowing from the direction of the Argos plant (the purple indicator on the map below).





We Can't Breathe

Environmental Protection Agency data compiled by the Houston Chronicle shows that there are at least 180 concrete batch plants in Harris County alone, the most in Texas! There are 8 in Aldine; and on the other side of I-45 in District B, there are more than a dozen! These are all disadvantaged environmental justice communities. Say NO to this permit!

Figuratively Killing an Entire Community

Neighbors most commonly complain about dust and particulate matter (PM) emissions from concrete batch plants like Argos.

Particulate matter is linked to serious health conditions, including reduced lung development in children, higher rates of asthma, bronchitis, heart disease and cancer. The most recent data, compiled from a range of sources, including satellite imagery, show that, in 2015 alone, particulate matter was linked to <u>5,200 premature deaths</u> in Houston.

That's this entire area within one (1) mile ... DEAD.

Volatile organic compounds (VOCs) are also a problem at concrete batch plants, says Dr. Latrice Babin, director of Harris County Pollution Control. VOCs can irritate the eyes and respiratory system and cause shortness of breath, headaches, fatigue, skin problems and impair the memory. Higher concentrations of VOCs can damage the liver, kidney and brain, according to Babin.

Cause of Emission Event or Excess Opacity Event, or Reason for Scheduled Activity:

At 9:25am, an Aggregate Hauler (third party) cement tanker started the offloading process of blowing off fly ash into the Plant 1 fly ash silo. At approximately 10:06am, the Plant Manager noticed a cloud of dust in the vicinity of the area of the silos of Plant 1 Commercial Side (West Plant), at the same time the Plant Manager noticed the front end loader (FEL) operator signaling to the bulk tanker operator to shut down the offloading process. The cause of the event: There is a 1' long 3" diameter pipe (pressure release pipe) on top of the silo with a spring activated cap attached to the silo top. The spring activated cap was opened causing fly ash to be released into the air. The pipe with the spring activated cap is located on the top of the silo about 70' in the air. The silo pipe is located at the northwest area of the property. Maintenance team inspected the plant and found the pressure release, spring activated cap to be in good condition. The inspection did reveal a broken electrical wire that supplied power to the silo alarm devices and fill pipe pinch valve. Upon last inspection the alarms were operational and since then, the silo has not reached the highlight alarm capacity to trigger the silo alarm devices and pinch valve; therefore, there was no knowledge the silo alarms were not functional.

Actions Taken, or Being Taken, to Minimize Emissions And/or Correct the Situation:

The FEL operator obtained the attention of the bulk tanker operator and instructed the operator to cease the offloading process of bulk material to the silo. The bulk tanker operator began the process of closing the valves to the tanker pods and depressurization of the vessel. The Plant Manager climbed to the top of the fly ash silo to assess the point of released emissions. Our maintenance team was dispatched to the plant to conduct inspection of silo and equipment. The broken power supply wire for the silo alarm devices and pinch valve was discovered. The broken power wire that supply power to the silo alarm devices and pinch valve was repaired. To prevent any future failures, and as a safety precaution, other repairs were performed: the silo pressure release valve, high light alarm control box and e-stop switch were replaced. The silo alarm devices were rewired into the load point camera system power, in the event of future power loss, the power loss can easily be identified when the load point camera is no longer visible. Operational controls and procedures with operator evaluation of silo inventory levels are being reviewed.

Basis Used to Determine Quantities and Any Additional Information Necessary to Evaluate the Event:

The wind speed at the time of the event was 11mph. The wind direction was from the E-SE. Fly ash emissions were directed to the northwest property line. Fly ash was discovered on the public roadway just north of our property line and on the property of our neighbor just north of our property. A third-party hazardous material company was called out to address the impacted areas. Our property was swept, the roadway north of our property was addressed and the affected areas of the neighbor's property was addressed. The hazardous material company addressed the detailing concerns of the vehicles on the neighbor's property. Our facility continued to wash down the emissions, affected areas on site. The reported amount of about 3/4 ton or less was determined to have escaped the silo, 1/4 of that amount left the property line. The reported amount of 1/4 ton was determined by calculating the inventory difference in our batching computer system, silo inventory and remaining product inventory of the bulk tanker vessel, and the amount of product that was captured by the dust collector housing and dust collector vent lines, more or less 1/2 ton. The emissions that escaped the property line was extremely minimal and was remediated completely by means of a street sweeper, concerning emissions that settled on the roadway. The minimal amount of emissions that settle on the neighbor's property was addressed by third party company detailing the affected vehicles. 

Federal environmental justice policy directs EPA to address environmental injustices to the full extent authorized by law. This policy was based, in part, on the nation's civil rights laws, which were enacted to address all forms of discrimination. EPA recognizes that it is time to use the full extent of its enforcement authority under federal civil rights laws, including Title VI of the Civil Rights Act of 1964."

The document goes on to say that "historically, industrial facilities have been sited, have expanded, and have added to the pollution burden in already vulnerable communities without due consideration of whether, either intentionally or in effect, the decisions allowing such outcomes are discriminatory under civil rights law or unfair under environmental justice policies. By considering the principles of environmental justice, complying with federal civil rights laws, and complying with applicable state environmental justice and civil rights policies


and laws, environmental permitting programs can better identify and address discriminatory or unfair permitting processes and outcomes. States and other recipients administering environmental permitting programs can adopt a routine process of screening for EJ and civil rights concerns early in the permitting process. If a permit applicant initiates pre-application discussions, knowledge gained from conducting an early EJScreen can make early discussions more meaningful and productive and add predictability and efficiency to the permitting process. This type of screening will indicate whether a permitting decision has the potential to cause or contribute to significant public health or environmental impacts, whether the community may be particularly vulnerable to any adverse effects of the proposed permitting action, and whether the community is already disproportionately bearing public health or environmental burdens. A sound screening practice will also provide important information to states and other recipients as to whether there are residents of the affected community who could be disproportionately subjected to adverse health, environmental, and/or quality of life impacts on the basis of race, color, or national origin (including LEP status). This screening process will also provide valuable information for the development of plans to meaningfully involve the affected community. For example, demographic information gathered during this screening process will help inform action to ensure meaningful access for persons with limited English proficiency, persons with disabilities, persons of different ages, and persons who are low-income who may lack access to the internet or necessary equipment. Finally, and critically, screening may inform recipients as to whether a more extensive analysis of potential disproportionate impacts would aid them in avoiding a violation of Title VI." Best Practices for Screening can be found in the FAQ document and include using the EPA's EJScreen tool found at https://www.epa.gov/ejscreen.

The EPA's EJScreen reveals that most of the area within one half mile of the Argos plant is in the 95th percentile for Particulate Matter on the environmental justice index compared to the state of Texas as a whole. The EJ index highlights block groups with the highest intersection of low-income populations, people of color, and a given environmental indicator (particulate matter was the selected index shown in the map below).



The map also shows there are five churches and two schools within 0.5 miles of the Argos plant. Within one mile of the Argos plant there are 12 additional schools, three additional schools and three other industrial facilities that are regulated by the EPA for air pollution. Expanding the radius to two miles includes an additional four more federally regulated facilities for air pollution.

The Threshold Index feature of the EJScreen compiles various EJ indexes on a single map, which provides a cumulative outlook on vulnerable populations facing higher pollution burdens. The EJScreen reveals that many census blocks in the immediate vicinity of the Argos plant (colored green in the map below) experience the intersection of low-income populations, people of color, and six different air quality related environmental indicators where exposure is in the 85th percentile or higher compared to the state of Texas as a whole.




Exposure to poor air quality has health impacts. The City of Houston's Asthma Coalition recently identified zip code 77022 as an "Asthma High Burden Zip Code."

Readings at the nearby Houston North Wayside monitor (EPA Site Number: 482010046) and Houston North Loop (EPA Site Number: 482011052) have consistently shown some of the highest PM2.5 levels in the Houston-Galveston-Brazoria (HGB) region. Readings at the Wayside monitor show PM2.5 concentrations over the past 11 months exceed the current annual NAAQS threshold of $12\mu g/m3$, threatening to push the region into nonattainment status for this pollutant.







nitrogen oxides, and volatile organic compounds. These pollutants have been linked to a host of serious health problems, including respiratory and cardiovascular diseases, cancer, and developmental and neurological disorders. Children are particularly vulnerable to these pollutants, as their lungs are still developing and they breathe in more air per pound of body weight than adults. The proposed location of this plant is simply unacceptable. Not only is it situated in close proximity to two elementary schools, but it is also located in an area that is already burdened by a high level of air pollution. According to data from the Environmental Protection Agency, Harris County is already in nonattainment for several air pollutants, including ozone and particulate matter. The addition of this plant would only exacerbate the problem and put the health of the community at even greater risk. I urge you to deny the renewal of Air Quality Permit Number 105998. The health and safety of the community must be given the utmost priority, and allowing this plant to continue operating would be a grave mistake. Instead, we must work together to find cleaner and safer ways to produce concrete that do not put the health of the community at risk. Thank you for your attention to this matter.
