**APPLICANT TREASURE ISLAND LAGUNA AZURE, LLC’S REPLY TO
EXCEPTIONS TO THE PROPOSAL FOR DECISION**

Treasure Island Laguna Azure, LLC (“*Treasure Island*”) files the following Reply to Exceptions to the Proposal for Decision (“*PFD*”) issued by the Administrative Law Judge (“*ALJ*”) regarding the petitions to create Grayson County Municipal Utility District (“*MUD*”) Nos. 6A and 6B (“*Petitions*”).

As the ALJ has aptly concluded, the City of Van Alstyne’s ‘exceptions’ to the PFD are not exceptional; they are the very same arguments that the City made in its closing briefs following the conclusion of the hearing on the merits. In other words, the City takes exception to the ALJ’s PFD by merely regurgitating arguments that the ALJ previously heard, considered, and rejected. Accordingly, the City’s Exceptions provide no basis for amending or reconsidering the ALJ’s PFD or any provision of the ALJ’s proposed final order.
