**COMMENTS:** As a landowner that will be directly impacted by this proposed MUD I would like to strongly object to its approval. My family has owned and farmed the same Ellis County land since the 1850's. Boggy Branch meets Cottonwood Creek at the heart of our property (we own 400 acres at Ozro Road and Smith Road). Yes, some of this land has always been in a flood plain but it was still usable for cattle grazing and hay bailing. Over the past 20 years with development upstream we continue to lose usable land to erosion, sloughs and increased flooding. We have spent countless dollars moving fence lines (that were fine for the last 80 years) and fighting the erosion. When does this stop? Why do we have to keep carrying this burden to maintain what is ours because others develop with no consideration of how it will impact those downstream? Maybe the water these muds release is within tolerable environmental standards (but maybe not) There are other environmental factors like loss of grazing land for livestock, limiting hay production for livestock, possible contamination from increased flooding, etc... Is the TCEQ considering these factors when approving MUDS for these large developments that will also greatly increase surface runoff? I have numerous photos I can share that show what we have been dealing with. I'm happy to share these and discuss further if given the opportunity.


*My 177 acres on Maypearl city limits are in agriculture but use is completely limited to hay production because of the extensive flooding that occurs during significant rains. Some years the land is deeply submerged from 3-6 times, and road closures of FM 66 at FM 916 are routinely expected. No livestock can be grazed on the 177 acres due to the risk of drowning. Citizens must detour for miles to avoid this major intersection after the creeks leave their banks.*

*A low water crossing is my only access to 72 of these acres which are west of the Maypearl concrete bridge. Cottonwood Creek (sometimes called East Fork of Chambers Creek when near town) and North Fork of Chambers Creeks are the sources of flooding producing what locals refer to as "Lake Maypearl". Flooding will be exacerbated by a sewer plant in the Circle S development as Spring Branch discharges into Armstrong Creek and then into Cottonwood Creek. My ability to lease my land for hay production will be harmed significantly when effluent together with storm water combine to overflow the present creek banks with regularity. Nearby homes, the post office, my barns, corral, and the bank could also be flooded after heavy downpours.*

*Two Continuous Conservation Reserve Program riparian buffers are in place on both creeks where my hay production is not feasible. They incorporate over 62 acres, and each is 70 feet wide and over 4000 feet long. These contracts were established to serve as erosion control, and they also act as wildlife corridors. Their purposes will be negatively impacted by any increased flooding in either Cottonwood or North Chambers Creeks. Please see my attached pictures.*

*Flood studies have not been updated to reflect the impact of proposed MUDs and sewer plants on these 2 creeks and adjoining Maypearl acreage. Sewer effluent safety and storm water volume should both be considered in the studies. Western Ellis County citizens are asking for flood control lakes of the type that exist in other parts of the county. Until they are built, we are not safe from the increased storm water and sewer plant effluent that will flow our direction.*

**COMMENTS:** I am concerned about the quality and volume of water in Cottonwood and North Chambers Creeks. I have over 4000 linear feet of each creek in a riparian buffer. Each one is 70 feet wide and they serve as wildlife corridors and prevent erosion in the adjoining 177 acres that I own. Up to 6 times per year these creeks both completely submerge my adjacent hay land and frequently submerge the intersection of FM 916 and FM 66 on the Maypearl city limits. Roads become impassable! Livestock can't graze these acres due to flash flooding. Any increase at all in flow will potentially have treated sewer effluent flooding the grasses produced for these animals. Loss of wildlife habitat will happen more regularly as displacement occurs more often. There is no flood control for these creeks and so, I request an engineering report that will measure the impact of storm runoff that will increase after this sewer permit is approved for this huge development. Sewer effluent volume and quality is not the only impact that TCEQ should consider!
