Re: Petition for the creation of Williamson County Municipal Utility District No. 50; TCEQ Docket No. 2024-1722-DIS

The above-referenced matter is scheduled to be considered by the Texas Commission on Environmental Quality ("Commission") at its December 18, 2024, public meeting. On November 25, 2024, Cathy Moore and Mark Albrecht (Petitioners) filed a request for continuance of this matter. The continuance request states that the Petitioners and their representatives have been in active discussions with Williamson County, Texas, the sole hearing requester in this matter, and believe that a mutually agreeable resolution may be achieved between the parties without Commission action. To facilitate a settlement, the Petitioners request that the Petition remain pending and for the hearing request matter be removed from the December 18, 2024, agenda.

The TCEQ's Executive Director and Office of Public Interest Council have both indicated that they do not oppose a continuance of this matter.
