Re: Application by Caddo Mills Laguna Land Azure, LLC for new Texas Pollutant Discharge Elimination System Permit No. WQ0016434001; TCEQ Docket No. 2024-1813-MWD

The above-referenced matter is scheduled to be considered by the Texas Commission on Environmental Quality (Commission) at its January 16, 2025, public meeting. On November 26, 2024, Caddo Mills Laguna Land Azure, LLC (Applicant) filed a motion for continuance of this matter. The continuance motion states that the Applicant and the City of Caddo Mills, the sole hearing requester, are in the process of finalizing a settlement agreement to allow for the withdrawal of the hearing request in resolution of this matter. To facilitate the settlement, the Applicant requests that the Application remain pending and for the hearing request matter be removed from the January 16, 2025, agenda.

The Applicant states it has consulted with the TCEQ's Executive Director and Office of Public Interest Council and both indicated they do not oppose a continuance of this matter. Pursuant to 30 TAC § 10.4 and the Commission's Resolution issued on February 2, 2009, Docket No. 2009-0059-RES, this matter is hereby continued and will be set for the Commission's agenda at a future date to be determined by the General Counsel.
