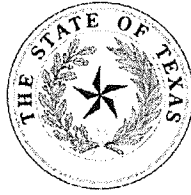

Re: Application of The Wolf Hollow II Power, LLC for Proposed Air Quality Permit No. 175173, GHGPSDTX238, and PSDTX1636; Request for Public Meeting and a Contested Case Hearing

To Whom It May Concern:

The proposed Air Quality Permit No. 175173, Issuance of Prevention of Significant Deterioration (PSD) Permit PSDTX1636, and Issuance of Greenhouse Gas (GHG) Prevention of Significant Deterioration (PSD) Permit GHGPSDTX23 would impact a significant number of residents within House District 58, and especially in Somervell County. Many residents in the near vicinity of the proposed Electric Generating Plant have expressed serious concerns about the potential for environmental pollution.

Therefore, on behalf of my constituents, I am formally requesting for the TCEQ to hold both a public meeting and a contested case hearing to address these concerns.
