

This location is a 487-acre cattle ranch which also has wooded areas and ponds used for hunting and fishing. There is also a homesite located on this property. I have the following concerns that this will negatively impact me and my property. 1. Cattle and wildlife will drink from the water. 2. Water from the creek seeps into the local watershed. 3. Property value will decrease. 4. Loss of income from hunting/fishing/cattle leases. 5. Sand and dirt will wash away with the amount discharged daily. What are the long-



lasting effects of drinking this water? Will it hurt the home owners who use water from wells? Will those who hunt/fish and eat the meat of the wildlife and fish get sick? Upon hearing this, those who lease the property for hunting and fishing will cancel the lease and cause a loss of income for that purpose. Also, no one will want to purchase the cattle if they know that they drink pollutant waste-water. Any family recreation will cease as we will not feel comfortable hunting, fishing, swimming and wading in the waste-water from Oasis of Texas. **COMMENTS:** I own property that connects to Oasis of Texas' property and touches Sand Creek in Moscow, Texas. I am concerned that the discharge of this amount of water will wash the creek bank and bed. This creek is not a constant-water flow creek and easily washes when floods occur. 50,000 gallons per day will significantly wash the creek bank. It is sand and washes on its own. We must consistently maintain the creek bank to keep our property from washing away. Also, it is my concern that animals and game will drink from the water. I'm not comfortable with the game animals I hunt for food ingesting waste water. I believe that this will drastically decrease the value of my property as well. After reading the planned path, Long King Creek goes through many, many family properties and ranches, feeding several ponds for



cattle along its path. I don't think those ranchers would appreciate having waste water drained into their ponds. I am AGAINST allowing this to occur. From what I've seen around the area, new developments are installing aerobic water treatment systems that spray the treated water back onto the owner's property, which waters their grass and fertilizes the ground. That sounds like a much better plan for the environment as a whole, as it keeps the grass and other plants healthy, keeping the dirt from washing away versus washing the "unnamed tributary" into Sand Creek, and it gives those employed in the aerobic system industry more jobs.
