APPLICANT HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 531'S EXCEPTIONS TO THE PROPOSAL FOR DECISION

TO THE HONORABLE COMMISSIONERS OF THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY:

Applicant Harris County Municipal Utility District No. 531 (the "District" or "Applicant") respectfully files these Exceptions to the Proposal for Decision ("PFD") recommended by the Administrative Law Judge ("ALJ") in the above-referenced case. The District agrees with the ALJ's recommendation that the Texas Commission on Environmental Quality ("TCEQ" or the "Commission") approve the application for Texas Pollutant Discharge Elimination System ("TPDES") Permit No. WQ0016334001 (the "Application") and issue the Executive Director's draft permit ("Draft Permit").

To support this recommendation, the ALJ properly presents findings of fact and conclusions of law in the proposed order for the Commission (the "Proposed Order"). The District offers two items for consideration in the review of the ALJ's Proposed Order:

1. <u>Finding of Fact No. 3</u>: Change the date of administrative completeness to <u>June</u>

April 21, 2023, consistent with page 2 of the PFD and the record in this case (*See* App. Ex. C, Tab C at 0060).

2. <u>After Finding of Fact No. 22</u>: Add the following finding of fact number 23 to note that the Applicant properly noticed the preliminary hearing convened by ALJ Stoebner on July 7, 2025, consistent with the record in this case (*See* App. Ex. C, Tab B at 00001-00004):

23. On May 30, 2025, notice of the preliminary hearing was published in English in the *Houston Chronicle*. The notice included the time, date, and place of the hearing, as well as the matters asserted, in accordance with the applicable statutes and rules.

The District appreciates the ALJ's careful consideration of the record evidence in this matter. The District respectfully requests that the Commission grant the Proposed Order recommended by the ALJ with the modifications described above.
