# **Requested Action:**

The Executive Director (ED) requests the Commission's approval for the appointment of six nominees and a president to serve on the Municipal Solid Waste Management and Resource Recovery Advisory Council (Advisory Council).

# **Background Information:**

The Advisory Council was created in 1983 by the 68th Texas Legislature and is composed of 18 members who serve staggered six-year terms and represent various segments of the state. The Advisory Council reviews and evaluates the effect of state policies and programs on municipal solid waste (MSW) management; makes recommendations on matters related to MSW management; recommends legislation to encourage the efficient management of MSW; recommends policies for the use, allocation, or distribution of the planning fund; and recommends special studies and projects to further the effectiveness of MSW management and resource recovery.

A Notice of Request for Nominations was published in the January 24, 2025, issue of the *Texas Register* (50 TexReg 580) to solicit nomination applications for nine vacant positions. One new position became vacant after the notice was published. The nomination period is open year-round and remaining vacant positions are filled as qualified applicants are nominated.

Staff received ten applications for six of the vacant positions. Staff did not receive any applications for the four elected official positions. Below is the list of advisory council vacant positions and recommended nominees.

## Appointments set to expire on August 31, 2027

# **Recommended Nominees**

## Thomas Parker

Position: A registered waste tire processor

Employment: All American Tire Recyclers, Fort Worth, TX

Mr. Parker, CEO of All American Tire Recyclers in Fort Worth, Texas, brings nine years of expertise in sustainable tire recycling and solid waste management. His leadership focuses on delivering eco-friendly solutions by transforming waste tires into valuable products like tire-derived fuel (TDF) and crumb rubber, which are used for asphalt applications and synthetic turf for sports fields. These initiatives significantly reduce landfill waste, support a circular economy, and promote responsible resource use.

## <u>Ken May</u>

As the Regional Programs Manager at the Capital Area Council of Governments (CAPCOG) since April 2022, Mr. May oversees grant programs for the Regional Services Division, particularly in solid waste management. His role involves managing up to 24 contracts annually, facilitating advisory committees, conducting workshops, drafting Request for Applications, and ensuring compliance with budgets and state policies. He also tracks legislation, provides program update reports to the CAPCOG Executive Committee, and provides consultation services. 

Mr. Mayfield has over 35 years of experience in the solid waste industry and currently serves as the Deputy Director of Solid Waste & Integrated Services for the North Texas Municipal Water District (NTMWD). In this role, he oversees strategy, planning, and management of NTMWD's solid waste system and fleet operations. This includes three transfer stations, one operating landfill, and two closed landfills, serving nearly one million residents across six counties. The transfer stations collectively handle approximately 2,200 tons of waste per day, while the landfill processes over 3,800 tons daily, with volumes increasing annually in this rapidly growing region. The Fleet department comprises an on-road heavy-duty truck shop and a light-duty service center, maintaining over 400 on-road and off-road vehicles and ancillary units. Mr. Mayfield is currently serving his third term with the Advisory Council. His term expires on August 31, 2029.

WHEREAS, the Comprehensive Municipal Solid Waste Management, Resource Recovery, and Conservation Act ("the Act"), Chapter 363, Subchapter C, Section 363.041 of the Texas Health and Safety Code states that the Municipal Solid Waste Management and Resource Recovery Advisory Council ("Advisory Council") shall consist of 18 members and contains requirements regarding the appointment and membership of the Advisory Council by the Texas Commission on Environmental Quality ("Commission");
