I have the privilege of representing Senate District 25 in the Texas Senate. I understand that the Commission is reviewing an application for a Texas Land Application Permit (TLAP) associated with a music venue proposed by Blizexas LLC. Many of my constituents have expressed their opposition to this facility and discussed with me significant issues that form the basis of their opposition.

For many reasons, the proposed location of this venue is inappropriate. I am particularly concerned about the lack of sufficient waste storage capacity, the size and location of the proposed waste disposal fields, and the lack of sufficient effluent limits (Nitrogen, Phosphorus, Total Suspended Solids, Biochemical Oxygen Demand). In addition, the geology of the area increases the likelihood that the proposed waste disposal will impact groundwater and surface water, including Barton Creek. For these and other reasons, I am opposed to the Commission's issuance of the TLAP. Please ensure that Commission staff performs a thorough review of Blizexas' permit application. I think that review will confirm my conclusion that Blizexas either should not be granted the TLAP or that significant changes to the proposed draft permit are required.

I appreciate your assistance in this regard.
