(1) Request Statement:

I request a contested case hearing.

(2) Description of Adverse Effects:

As a resident of a permanent residence located within 440 yards of the proposed facility, I believe I will be adversely affected by air emissions from this facility in ways not common to the general public. Specifically:

- Air Quality Impacts: Particulate matter and other air contaminants emitted from the facility are likely to affect my respiratory health and overall air quality in my neighborhood.
- **Noise Pollution:** Increased noise from plant operations and truck traffic will disturb the peaceful enjoyment of my property.
- Water Usage: Increased water use by the cement plant will continue to keep the Cow Creek Aquifer in Stage 4 water use. All properties around this site are on wells and will adversly effect the property owners availability of water and financial hardships to drill deeper wells or purchase water that is trucked in.
- **Traffic and Safety Concerns:** The additional truck traffic generated by the facility poses risks to pedestrian safety and increases congestion in our residential area.

(3) Location and Distance of My Property:

My property is located at 48 Old Comfort Road, Comfort, Texas 78013, which is approximately 750 feet from the proposed facility.

(4) Use of My Property:

I use my property for agriculture lease, my primary residence/homestead and wildlife management. These uses will be negatively impacted by the emissions, noise, and traffic associated with the facility. Specifically:
