COMMENTS: My family and I own property on the same creek that passes this RV park. We are situated down stream from where the proposed waste water will contaminate the creek. We utilize the creek for livestock watering and recreational use for my children and would appreciate no waste water and or chemicals used to treat waste contaminating our waters. We also have water wells drilled near the creek for our homes and the waste and chemicals could potentially over time make their way into our aquifers. This poses a serious health and environmental risk for us, our livestock and the native wildlife that depend on this creek for water.
