The Office of General Counsel invites US Ecology Winnie, LLC, to file a brief in response to the Petition to Revoke; the Executive Director and the Office of Public Interest Counsel to file response briefs to the Petition to Revoke and US Ecology Winnie, LLC's response; and Petitioner to file a reply to these response briefs. **US Ecology Winnie, LLC's** response brief must be filed with the Chief Clerk's Office no later than **Friday, June 20, 2025**, the **Executive Director's** and the **Office of Public Interest Counsel's** response briefs must be filed with the Chief Clerk's Office no later than **Friday, July 11, 2025**, and **Pipkin Ranch Holdings, LP** reply brief must be filed with the Chief Clerk's Office no later than **Friday, July 25, 2025**.

All responses and replies referenced in this letter must be filed with the Chief Clerk of the TCEQ and sent on the same day to all individuals on the attached mailing list. Parties may be served via email. Oral presentations before the Commission shall be limited to five minutes each for the Petitioner; US Ecology Winnie, LLC; the Executive Director; and the Office of Public Interest Counsel, excluding time for answering questions, unless the Chairwoman or General Counsel establishes other

limitations. The Petitioner may save part of their time for rebuttal, as the Petitioner bears the burden of proof on the Petition to Revoke.
