Air Quality Standard Permit for Concrete Batch Plants, Proposed Registration No. 172856

To Whom It May Concern,

For the reasons set forth herein below, TCEQ should consider terminating the permit application process for J7 Ready Mix, LLC's request for a Concrete Batch Plant permit, proposed to be located at 5426 FM 1187, Burleson, TX 76028 ("Rendon Community" herein).

It is my belief that J7 Ready Mix, LLC has acted in bad faith, without regard to the laws of the State of Texas, and with the intent of obfuscating the Rendon Community, who is directly and negatively impacted by this proposed concrete batch plant. This malintent by J7 Ready Mix, LLC is evidenced by the following actions and inactions:

- 1. J7 Ready Mix, LLC has failed and continues to fail to place a sign at the proposed site to indicate to the public the proposed location of the concrete batch plant, as required by Section 39.604 of the Texas Administrative Code.
- 2. J7 Ready Mix, LLC failed to publish notice in a newspaper of general circulation in the municipality in which the facility is located or is proposed to be located or in the municipality nearest to the location or proposed location of the facility, as required by Section 39.603(3) of the Texas Administrative Code, Public notice was published by J7 Ready Mix, LLC in the Fort Worth Weekly, which circulates in Northern Tarrant County and Denton County, but does not circulate in Southern Tarrant County, which is the jurisdiction of interest. If J7 Ready Mix, LLC truly wanted to provide notice to the public, they obviously would have published it in the Fort Worth Star-Telegram, which is actually circulated in the Rendon Community. Again, this is just another example of the applicant's bad faith.
- 3. J7 Ready Mix, LLC stated in their application that a technically completed copy of the TCEQ permit application was available for public viewing at the Burleson Public Library in Tarrant County. However, Burleson Public Library is located in Johnson County.

- 4. J7 Ready Mix, LLC provided no evidence that they had complied with the Alternative Language Publication requirements, as required by Section 39.418(b), Section 39.419(b), and Section 39.426 of the Texas Administrative Code.
- 5. J7 Ready Mix, LLC has already made substantial and expensive improvements to the property located at 5426 FM 1187, Burleson, Texas, as if they don't need to wait on TCEQ to review/consider the requested permit.
- 6. J7 Ready Mix, LLC has failed to request and obtain approval from Texas Department of Transportation for a safe driveway into the property located at 5426 FM 1187, Burleson, Texas. Instead of first obtaining approval, JR Ready Mix, LLC has moved forward with building their improvements.

Based on the foregoing reasons, TCEQ should consider terminating the current permitting process for the proposed J7 Ready Mix Concrete Batch Plant permit. These actions clearly indicate a pattern of behavior meant to shroud this application in darkness and preclude my constituents from actively participating in the TCEQ permitting process.
