COMMENTS: The applicant's activities should not restrict the City of Orange from expanding our current Sabine River effluent discharge capacity to 29 MGD upstream from the applicant's discharge point. This expansion redirects remaining discharges from Adam's Bayou (an impaired water) to the Sabine River. The City's permit is on a hold condition while the waters of Adam's Bayou continue to be under evaluation, limiting our ability to request a permit modification. This concern has been shared with the applicant and we have been advised "In regards to the City's future effluent permitting with TCEQ, neither CPChem nor GTPC will comment on these matters with the understanding that

we intend to pursue our individual effluent discharge permit in accordance with TCEQ requirements" as emailed to the City on 9/27/23. Your consideration of our concerns is appreciated. Adam Jack, P.E. Public Works Director City of Orange
