Texas Tax Code, Section 11.31 requires the Texas Commission on Environmental Quality (TCEQ) to form a permanent advisory committee to make recommendations to TCEQ commissioners on matters relating to property tax exemptions for pollution control property. The advisory committee is required to have representatives from industry, appraisal districts, taxing units, environmental groups, a school district or junior college, and other members who have substantial technical expertise in pollution control technology and environmental engineering. The committee positions to be filled include three industry representatives, two appraisal district representatives, one taxing unit representative, and one independent technical expert. Background:

House Bill (HB) 3206 and HB 3544, 81st Texas Legislature, 2009, amended Texas Tax Code, §11.31 to require the Texas Commission on Environmental Quality (TCEQ) to form a permanent advisory committee to make recommendations to TCEQ commissioners on matters relating to property tax exemptions for pollution control property. The Tax Relief for Pollution Control Property Advisory Committee (Advisory Committee) consists of 13 members, each of whom serves a four-year, staggered term. The Advisory Committee is required to include representatives from industry, appraisal districts, taxing units, environmental groups, a school or junior college district, and other members who have substantial technical expertise in pollution control technology and environmental engineering.

The committee positions expiring on December 31, 2025, include three industry representatives, two appraisal district representatives, one taxing unit representative, and one independent technical expert. One appraisal district representative position was vacated earlier this year when the committee member resigned his position. The Tax Relief for Pollution Control Property program solicited nominations for the Advisory Committee and received seven:

- three nominations to represent industry,
- two nominations to represent appraisal districts,
- one nomination to represent taxing units, and
- one nomination as an independent technical expert.

Requested Action:

It is recommended that all nominees be appointed to the committee in the positions for which they were nominated.

Tax Relief for Pollution Control Property Advisory Committee Request for Nominations

The Texas Commission on Environmental Quality (TCEQ) is currently accepting nominations for seven members to the Tax Relief for Pollution Control Property Advisory Committee (advisory committee) to serve four-year terms, beginning January 1, 2026, through December 31, 2029.

The following affiliation positions need to be filled on the committee: three industry representatives, two appraisal district representatives, one taxing unit representative, and one independent technical expert. Current advisory committee members whose terms are expiring may nominate themselves for reappointment and must be nominated to be considered for reappointment.

In 1993, Texas voters approved Proposition 2 (Prop 2), amending the Texas Constitution to authorize the Texas Legislature to exempt from ad valorem taxation "all or part of real and personal property used, constructed, acquired, or installed wholly or partly to meet or exceed rules or regulations adopted by an environmental protection agency of the United States, this state, or a political subdivision of this state for the prevention, monitoring, control, or reduction of air, water, or land pollution." The Texas Legislature implemented Prop 2 by enacting Texas Tax Code, §11.31. TCEQ adopted 30 Texas Administrative Code (TAC) Chapter 17, implementing Texas Tax Code, §11.31 and establishing the procedures for obtaining a "positive use determination" under the Tax Relief for Pollution Control Property Program. The goal of the program is to provide tax relief to individuals, companies, and political subdivisions that make capital investments to meet or exceed federal, state, or local environmental rules or regulations.

In 2009, Texas Tax Code, §11.31 was amended to require TCEQ to form a permanent advisory committee to make recommendations to TCEQ commissioners on matters relating to property tax exemptions for pollution control property. TCEQ commissioners appoint advisory committee members to serve four-year staggered terms.

Completed nomination forms must be submitted to TCEQ by 5:00 p.m. CDT on July 8, 2025. Nominations received after that date will only be considered if there are insufficient qualified nominees. Individuals may nominate themselves or someone else to the advisory committee, but TCEQ asks that only interested persons be nominated.

To Whom It May Concern,

Thank you for this opportunity to apply to be a representative for the Appraisal Districts on the Tax Relief for Pollution Control Property Advisory Committee. I have applied because I am the Director of Industrial and Utility Appraisals for the largest complex property tax appraisal firm in the state of Texas, Pritchard & Abbott, Inc. (P&A). P&A currently works for 112 of the 254 appraisal districts in Texas or 44% of the state. One of my primary responsibilities is to develop and maintain the power plant model used to appraise one hundred and sixty-four (164) power generation facilities where I see the direct impact of the recommendations that are made by this commission. For example, a power plant that I appraised last year had just received a new TCEQ exemption for their HRSG built in 1998.

Additionally, in my six years of experience in the industrial and utility property tax appraisal world, I have had my work referenced in various legal documents quoting Louisiana Tax Commission (LTC)¹ Hearing testimony that I provided, of which I have included the following excerpts:

State of Louisiana Tax Commission DOCKET NO. 23-22075-004²

"Ms. Khan testified that the appraisal for 2023 started in 2022 when IMT rendered 58.01% less than they had rendered in 2021 including a 68% reduction in the equipment for the project that gave them the 20,000,000-ton capacity. Ms. Khan testified that the 'missing' assets were not added back to the LAT filing for 2023, despite all of this equipment remaining at the site.

Ms. Khan noted that she and the Taxpayer used the same formula for calculating obsolescence with two notable differences. First, Ms. Khan used the actual throughput that was reported to her by the Taxpayer during her inspection of the property. Second, Ms. Khan applied a 50% floor to account for the lack of rendered cost. Ms. Khan testified that she typically does not employ the "floor" to account for market uncertainty, but used the floor in this case because of the missing, unreported costs.

With regard to the economic life of the subject machinery & equipment, Ms. Khan testified that there are other bulk terminals in Louisiana, all of which are assessed using a 20-year economic

life for machinery & equipment. Ms. Khan admitted that a 15-year economic life was previously used for the subject machinery & equipment, but this was changed for two reasons. First, for consistency and uniformity, as machinery & equipment at other bulk terminals in Louisiana were assessed using a 20-year economic life. Second, based on her review of the Commission's tables and economic life of similar assets, a 20-year economic life was indicated.......

Here the Commission finds that the Assessor's use of a 20-year economic life to be reasonable and supported by a preponderance of the evidence.......

The Taxpayer's witness, Bob Adair, calculated an obsolescence factor of 0.38 based on a utilization factor of 19.6%. The Assessor's witness, Karen Khan, calculated an obsolescence factor of 0.69 based on a utilization factor of 20.7%. The principal difference is the formula each witness used in calculating obsolescence. Specifically, Ms. Khan included a 50% floor to compensate for flaws in the formula, particularly the possibility that zero-utilization compared to capacity would produce an economic obsolescence factor of 100%, leading to conclusion of zero value for the equipment or facility. Ms. Khan's Economic Obsolescence report notes: "turning off a piece of equipment does not automatically mean that it must have zero value." Assessor Exhibit 11.

The Commission finds that the Assessor's use of a 50% floor is reasonable and supported by the evidence and testimony......."

Louisiana Board of Tax Appeals - BTA DOCKET NO. L01962³

"Appellant claims that the LTC and the Assessor exclusively relied on Ms. Khan's throughput/inutility analysis. By doing so, the LTC and the Assessor allegedly failed to consider Appellant's other evidence concerning functional and economic obsolescence. In particular, the Appellant points to evidence concerning the LCR's lack of a ULSD unit and the trend towards electric vehicles. Appellant further maintains that Ms. Khan's analysis failed to determine functional obsolescence separately from economic obsolescence.

The record reflects that Ms. Khan considered the effect of functional obsolescence on the FMV of the Property. In Assessor's Exhibit 5, Ms. Khan states that she treated the LCR's lack of a ULSD unit as economically "incurable" functional obsolescence under "Property Assessment Valuation 3rd Addition" by the IMO (International Association of Assessing Officers). Ms. Khan determined that the lack of a ULSD unit was "incurable" based on information provided by the Appellant. Specifically, the Appellant represented that a retrofit was not economically feasible.

"Incurable" functional obsolescence is, according to Ms. Khan, measured as the net income loss attributable to the deficiency in comparison with otherwise competitive properties. The Appellant did not provide the Assessor with income data. Instead, Appellant provided utilization data. Ms. Khan's approach is therefore supported by the evidence provided by the Appellant that is in the record developed before the LTC.

The Board also finds that the LTC did not err by disregarding the purported trend towards electric cars. The Appellant's evidence on this issue may suggest that a high-level shift in the market may occur at some point in the future. However, the effects of that trend, if any, are currently remote and speculative. That is not enough to tip the balance of evidence in the Appellant's favor. Moreover, the evidence related to these concerns does not show that the Assessor should have increased the economic obsolescence factor by an amount greater than the 9% upward adjustment that the Assessor did grant in addition to the factor determined by Ms. Khan.

CONCLUSION:

The Assessor's calculation of obsolescence for the LCR is supported by utilization data and the Assessor's throughput/inutility analysis. The Appellant's evidence concerning other refinery sales is vague as to the allocation of the total price, particularly with respect to what value was allocated to the category of Property that is at issue in this case. The appellant's evidence concerning potential market changes in the future is speculative and inadequate when put against the assessor's evaluation methodology and supporting date. Furthermore, the Assessor increased the obsolescence factor that their expert calculated by an additional 9%, and the Appellant's evidence does not show that the Assessor should have granted an even larger adjustment. Thus, a preponderance of the evidence weighs in favor of the valuation determined by the Assessor and upheld by the LTC. Accordingly, the Board affirms the LTC's decision to uphold the Assessor's valuation of the Property."

Prior to my current role, I was predominately a project engineer in a variety of industries for almost fifteen years. The details of which are specified on my resume. These roles, along with a rigorous exam, gave me the experience and recommendations required to obtain my Texas Professional Chemical Engineering License (PE), which I believe will be invaluable for this group. Oil & Gas Appraisal

The appraisal of utilities (telecommunication, electric, water, pipelines, and railroads) is a complex and challenging task, often requiring the appraiser to consider all the basic approaches to value (Cost, Market, and Income).

The appraiser then correlates the indicated value by each approach to derive the most appropriate and defendable opinion of fair market value. Utility valuations are usually performed for the subject company as a whole (unit approach), and then total value is allocated to specific assets and locations.

Of all the categories of property we appraise, utility appraisals are typically the largest in terms of market value because the scope of a utility company's operations can encompass a large geographic area and customer base, even across state lines.

P&A utility appraisers have the experience and background necessary to understanding the unique markets in which utility companies operate.

Personal Property Appraisal



Unlike mineral interests or utility properties, the appraisal of personal property requires a visual inspection of the assets to determine fair market value.







WHEREAS, the terms of the following seven members of the Advisory Committee expire on December 31, 2025:

- Hugh Landrum, Jr., as a representative from appraisal districts;
- Martha Landwehr, as a representative from industry;
- Bill Longley, as a representative from taxing units;

 Vacant position due to resignation, as a representative from appraisal districts; and

WHEREAS, the Commission published notice in the June 6, 2025, issue of the *Texas Register* (50 TexReg 3514) soliciting nominations for the Advisory Committee.
