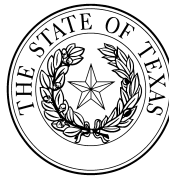

The Agenda meeting will be held in person in Room 201S of Building E at the Commission's offices located at 12100 Park 35 Circle in Austin, Texas, and virtually.

During the meeting, the Commission will hear oral argument on affectedness. On LH 207, LP and Florence FM 970 Ventures, LLC's Petitions, Williamson County will have five minutes; LH 207, LP and Florence FM 970 Ventures, LLC will collectively have five minutes; and the Executive Director and the Office of Public Interest Counsel will each have five minutes for their respective oral presentations. On Sunny Jane Elizabeth Ahrens and Thomas Edward O'Kelley's Petition, Luanne Langley, Johnson County Commissioner Larry Woolley, and State Representative Helen Kerwin will collectively have six minutes; Sunny Jane Elizabeth Ahrens and Thomas Edward O'Kelley will collectively have six minutes; and the Executive Director and the Office of Public Interest Counsel will each have five minutes for their respective oral presentations. The Hearing Requesters may reserve time for rebuttal.
