Dear Chief Clerk Gharis,

I am writing on behalf of the future of our Edwards Aquifer Recharge and Transition Zones, and the constituents living near the proposed Hays Commons Development who have many concerns regarding the Texas Land Application Permit # WQ0016373001.

For TCEQ to allow the disposal of treated wastewater within the Edwards Aquifer Recharge Zone and Transition Zone does not seem to align with the mission of the Texas Commission on Environmental Quality which includes "protect our state's public health and natural resources". The goal for clean water and safe management of wastewater should be reflected in the impact this permit would have on this highly sensitive Edwards Aquifer Recharge and Transition Zones. TCEQ has not shown that it has requested increased regulations with increased testing requirements in this area and how this will affect the recharge zone. At a time with many water concerns, maintaining a healthy aquifer should be a high priority for Texas and TCEQ.

Our responsibility to protect the Texas air, water, and natural resources, such as the Edwards Aquifer, is a paramount reason in declining this permit. I respectfully request that my office continue to be informed on activity regarding proposed TLAP# WQ0016373001.
