### **Ben O Corp Reply on Hearing Requests**

As noted by the Office of Public Interest Council (OPIC) in its response to hearing requests, Ben O Corp through Michael Ohlendorf raised several material issues that are proper for the Texas Commission on Environmental Quality (TCEQ) to refer to the State Office of Administrative Hearings (SOAH) for a contested case matter. The issues that TCEQ should refer are:

- 1. Whether the Facility and draft permit comply with the Texas Surface Water Quality Standards and are adequately protective of water quality.
- 2. Whether the Facility and draft permit are adequately protective of human health and animal life.
- 3. Whether the draft permit is adequately protective of requestor's use and enjoyment of property, including recreational use of Dickinson Creek and livestock watering.
- 4. Whether the discharge route is properly characterized in the application and draft permit and, as an operational feature of the Facility, will function properly.

The issues identified above were timely raised and not withdrawn by Ben O Corp during the comment period for this application and each of the issues embody considerations that are material to TCEQ's decision whether to approve the application and grant the draft permit. To summarize Ben O Corp's non-water quality related concerns with the draft permit as "issues with flooding" as the Applicant does, artificially narrows the issues raised by Ben O Corp and denies Ben O Corp the opportunity to be heard before SOAH on material issues related to the flow of treated effluent through Dickerson Creek raised during the comment period.

Additionally, while the issues recommended to be referred by the Executive Director are similar to those recommended by OPIC, Ben O Corp requests TCEQ refer the issues as articulated by OPIC as they hew more closely to the issues and concerns raised by Ben O Corp

during the comment period by allowing broader consideration of the Texas Surface Water Quality Standards located at 30 TAC Chapter 307 rather than limiting consideration to water quality standards related only to aquatic life, livestock, and existing uses.

For the reasons set out here and in Ben O Corp's hearing request, Ben O Corp respectfully requests that TCEQ refer this matter to SOAH for a contested case hearing on the issues listed in the reply.
