#### **EXECUTIVE DIRECTOR'S RESPONSE TO HEARING REQUESTS**

#### I. INTRODUCTION

The Executive Director of the Texas Commission on Environmental Quality (commission or TCEQ) files this response (Response) to the requests for a contested case hearing submitted by persons listed herein regarding the above-referenced matter. The Texas Clean Air Act (TCAA), Texas Health & Safety Code (THSC) § 382.056(n), requires the Commission to consider hearing requests in accordance with the procedures provided in Tex. Water Code (TWC) § 5.556. This statute is implemented through the rules in 30 Texas Administrative Code (TAC) Chapter 55, Subchapter F.

A map showing the location of the proposed plant is included with this Response and has been provided to all hearing requesters listed on the mailing list for this application. In addition, the technical review summary, which includes a compliance summary, and a copy of the Standard Permit for Concrete Batch Plants prepared by the Executive Director's staff have been filed as backup material for the commissioners' agenda. The Executive Director's Response to Public Comment (RTC), which was transmitted by the chief clerk to all persons on the mailing list, is on file with the chief clerk for the commission's consideration.

#### II. PLANT DESCRIPTION

Raptor Ready Mix Inc (Applicant) has applied to TCEQ for a Standard Permit under THSC § 382.05195. This will authorize the construction of a new facility that may emit air contaminants.

This permit will authorize the Applicant to construct a temporary Concrete Batch Plant located at the following driving directions: From downtown Fort Worth, travel west on I-30 for approximately 9 miles to I-820 N (Exit 5A). Travel north on I-820 for approximately 2.2 miles to Silver Creek Road (Exit 5B). At the light, turn left (West) on Silver Creek Road and travel approximately 0.8 miles. The entrance to the jobsite will be on the west side of Silver Creek Road, Fort Worth, Tarrant County, Texas 76052. Contaminants authorized under this permit include particulate matter, including (but

not limited to) aggregate, cement, road dust, and particulate matter with diameters of 10 microns or less and 2.5 microns or less ( $PM_{10}$  and  $PM_{25}$ , respectively).

#### III. PROCEDURAL BACKGROUND

Before work begins on the construction of a new facility that may emit air contaminants, the person planning the construction must obtain an authorization from the commission. This permit application is for an initial issuance of Air Quality Permit Number 177217L002.

The permit application was received on October 18, 2024, and declared administratively complete on October 23, 2024. The Consolidated Notice of Receipt of Application and Intent to Obtain Permit and Notice of Application and Preliminary Decision (consolidated public notice) for this permit application was published in English on November 22, 2024, in the Fort Worth Star Telegram and in Spanish on November 19, 2024, in La Prensa Comunidad. A public meeting was held on April 3, 2025, at the National Hall, 3316 Roberts Cut Off Road, Fort Worth, Texas 76114. The notice of public meeting was mailed on February 25, 2025. At the public meeting, TCEQ became aware that a copy of the application, Executive Director's preliminary decision, and standard permit was not made available at the public viewing place during the public notice and comment period. The applicant notified TCEQ on April 8, 2025, that the materials were placed at the White Settlement Library, 8215 White Settlement Road Fort Worth, Texas 76108. The public comment period was extended from April 3, 2025, to May 7, 2025, to allow the public to provide further comments on the permit application materials. Because this application was received after September 1, 2015, it is subject to the procedural requirements of and rules implementing Senate Bill 709 (84th Legislature, 2015).

The Executive Director's Response to Public Comment was filed with the Chief Clerk's Office on June 6, 2025, and instructions on accessing the electronic copy of the RTC and how to request a hard copy were mailed to all interested persons on June 12, 2025, including persons who asked to be placed on the mailing list for this application and those who submitted comments or requests for a contested case hearing. The cover letter attached to the RTC included information about making requests for a contested case hearing or requests for reconsideration of the Executive Director's decision. The letter also explained that hearing requestors should specify any of the Executive Director's responses to comments they dispute and the factual basis of the dispute, in addition to listing any disputed issues of law or policy. The time for requests for reconsideration and hearing requests ended on July 14, 2025.

#### IV. THE EVALUATION PROCESS FOR HEARING REQUESTS

House Bill 801 established statutory procedures for public participation in certain environmental permitting proceedings, specifically regarding public notice and public comment and the Commission's consideration of hearing requests. Senate Bill 709 revised the requirements for submitting public comment and the Commission's consideration of hearing requests. The evaluation process for hearing requests is as follows:

# A. Response to Hearing Requests

The Executive Director, the Public Interest Counsel, and the Applicant may each submit written responses to hearing requests. 30 TAC § 55.209(d).

Responses to hearing requests must specifically address:

- 1) whether the requestor is an affected person;
- 2) which issues raised in the hearing request are disputed;
- 3) whether the dispute involves questions of fact or of law;
- 4) whether the issues were raised during the public comment period;
- 5) whether the hearing request is based on issues raised solely in a public comment withdrawn by the commenter in writing by filing a withdrawal letter with the chief clerk prior to the filing of the Executive Director's Response to Comment;
- 6) whether the issues are relevant and material to the decision on the application; and
- 7) a maximum expected duration for the contested case hearing.

30 TAC § 55.209(e).

# **B.** Hearing Request Requirements

In order for the Commission to consider a hearing request, the Commission must first determine whether the request meets certain requirements:

Affected persons may request a contested case hearing. The request must be made in writing and timely filed with the chief clerk. The request must be based only on the requestor's timely comments and may not be based on an issue that was raised solely in a public comment that was withdrawn by the requestor prior to the filing of the Executive Director's Response to Comment.

30 TAC § 55.201(c).

A hearing request must substantially comply with the following:

- give the time, address, daytime telephone number, and where possible, fax number of the person who files the request. If the request is made by a group or association, the request must identify one person by name, address, daytime telephone number, and where possible, fax number, who shall be responsible for receiving all official communications and documents for the group;
- 2) identify the person's personal justiciable interest affected by the application, including a brief, but specific, written statement explaining in plain language the requestor's location and distance relative to the proposed facility or activity that is the subject of the application and how and why the requestor believes he or she will be adversely affected by the proposed facility or activity in a manner not common to members of the general public;
- 3) request a contested case hearing;
- during the public comment period and that are the basis of the hearing request. To facilitate the commission's determination of the number and scope of issues to be referred to hearing, the requestor should, to the extent possible, specify any of the Executive Director's responses to comments that the requestor disputes and the factual basis of the dispute and list any disputed issues of law; and
- 5) provide any other information specified in the public notice of application.

30 TAC § 55.201(d).

# C. Requirement that Requestor be an Affected Person/"Affected Person" Status

In order to grant a contested case hearing, the Commission must determine that a requestor is an "affected" person. 30 TAC § 55.203 sets out who may be considered an affected person.

a) For any application, an affected person is one who has a personal justiciable interest related to a legal right, duty, privilege, power, or economic interest affected by the application. An interest common to members of the general public does not quality as a personal justiciable interest.

- b) Except as provided by 30 TAC § 55.103, governmental entities, including local governments and public agencies with authority under state law over issues raised by the application may be considered affected persons.
- c) In determining whether a person is an affected person, all factors shall be considered, including, but not limited to, the following:
  - 1) whether the interest claimed is one protected by the law under which the application will be considered;
  - 2) distance restrictions or other limitations imposed by law on the affected interest;
  - 3) whether a reasonable relationship exists between the interest claimed and the activity regulated;
  - 4) likely impact of the regulated activity on the health and safety of the person, and on the use of property of the person;
  - 5) likely impact of the regulated activity on use of the impacted natural resource by the person;
  - for a hearing request on an application filed on or after September 1, 2015, whether the requestor timely submitted comments on the application which were not withdrawn; and
  - 7) for governmental entities, their statutory authority over or interest in the issues relevant to the application.

#### 30 TAC § 55.203.

In regard specifically to air quality permits, the activity the commission regulates is the emissions of air contaminants into the atmosphere. Any person who plans to construct or modify a facility that may emit air contaminants must receive authorization from the commission. Commission rules also include a general prohibition against causing a nuisance. Further, for air quality permits, distance from the proposed facility is particularly relevant to the issue of whether there is a likely impact of the regulated activity on a person's interests because of the dispersion and effects of individual air contaminants emitted from a facility.

Additionally, this application is for registration for the Standard Permit for Concrete Batch Plants. Hearing requests on a concrete batch plant standard permit are subject to the requirements in THSC § 382.058(c), which states that "only those persons actually residing in a permanent residence within 440 yards of the proposed plant may request a hearing...as a person who may be affected."

For applications filed on or after September 1, 2015, 30 TAC § 55.201(d) allows the commission to consider, to the extent consistent with case law:

- 1. the merits of the underlying application and supporting documentation in the commission's administrative record, including whether the application meets the requirements for permit issuance;
- 2. the analysis and opinions of the Executive Director; and
- 3. any other expert reports, affidavits, opinions, or data submitted by the Executive Director, the applicant, or hearing requestor.

# D. Referral to the State Office of Administrative Hearings

"When the commission grants a request for a contested case hearing, the commission shall issue an order specifying the number and scope of the issues to be referred to SOAH for a hearing." 30 TAC § 50.115(b). The commission may not refer an issue to SOAH for a contested case hearing unless the commission determines that the issue:

- 1) involves a disputed question of fact or a mixed question of law and fact;
- 2) was raised during the public comment period by an affected person whose hearing request is granted; and
- 3) is relevant and material to the decision on the application.

30 TAC § 50.115(c).

#### V. ANALYSIS OF THE HEARING REQUESTS

The Executive Director has analyzed the hearing requests to determine whether they comply with Commission rules, if the requestors qualify as affected persons, what issues may be referred for a contested case hearing, and what is the appropriate length of the hearing.

For a registration for a concrete batch plant standard permit, THSC § 382.058(c) states that "only those persons actually residing in a permanent residence within 440 yards of the proposed plant may request a hearing...as a person who may be affected." Based on the addresses provided by the hearing requesters, the Executive Director determined that the hearing requesters listed below reside more than 440 yards from the proposed

plant. Therefore, the Executive Director recommends that the Commission find that the following hearing requesters are not affected persons and deny their hearing requests.

### **Fay Adamson**

The Executive Director reviewed the factors found in 30 TAC § 55.201(c) and (d), and § 55.203 for determining whether a requestor is an affected person, and recommends the commission find that Fay Adamson is not an affected person.

Fay Adamson submitted three timely hearing requests during the comment period. The hearing requests were in writing and provided the required contact information. With the address provided by Ms. Adamson, the Executive Director determined that Ms. Adamson's residence is approximately 869.24 yards from the proposed location of the plant, which is greater than 440 yards from the proposed plant. Therefore, the Executive Director requests that the Commission find that Fay Adamson is not an affected person and that her hearing request be denied.

In her public hearing request, Fay Adamson raised the following issues:

- **Issue 1:** Whether the permit would be protective of human health and safety.
- **Issue 2:** Whether the permit will negatively affect air quality.
- **Issue 3:** Whether the proposed plant would contribute to cumulative impacts.

#### Sheila Anderson

The Executive Director reviewed the factors found in 30 TAC § 55.201(c) and (d), and § 55.203 for determining whether a requestor is an affected person, and recommends the commission find that Sheila Anderson is not an affected person.

Sheila Anderson submitted three timely hearing requests during the comment period. The hearing requests were in writing and provided the required contact information. With the address provided by Ms. Anderson, the Executive Director determined that Ms. Anderson's residence is approximately 7885.88 yards from the proposed location of the plant, which is greater than 440 yards from the proposed plant. Therefore, the Executive Director requests that the Commission find that Sheila Anderson is not an affected person and that her hearing request be denied.

In her public hearing request, Sheila Anderson raised the following issues:

- **Issue 1:** Whether the permit would be protective of human health and safety.
- **Issue 2:** Whether the permit will negatively affect air quality.

# **Dean Arnove**

The Executive Director reviewed the factors found in 30 TAC § 55.201(c) and (d), and § 55.203 for determining whether a requestor is an affected person, and recommends the commission find that Dean Arnove is not an affected person.

Dean Arnove submitted one timely hearing request during the comment period. The hearing request was in writing and provided the required contact information. With the address provided by Mr. Arnove, the Executive Director determined that Mr. Arnove's residence is approximately 695.66 yards from the proposed location of the plant, which is greater than 440 yards from the proposed plant. Therefore, the Executive Director requests that the Commission find that Dean Arnove is not an affected person and that his hearing request be denied.

In his public hearing request, Dean Arnove raised the following issues:

- **Issue 1:** Whether the permit would be protective of human health and safety.
- **Issue 2:** Whether the permit will negatively affect air quality.

With the address provided by Mr. Benda, the Executive Director determined that Mr. Benda's residence is approximately 854.53 yards from the proposed location of the plant, which is greater than 440 yards from the proposed plant. Therefore, the Executive Director requests that the Commission find that Robert D. Benda is not an affected person and that his hearing request be denied.

In his public hearing request, Robert D. Benda raised the following issues:

- **Issue 1:** Whether the permit would be protective of human health and safety.
- **Issue 2:** Whether the permit will negatively affect air quality.
- **Issue 3:** Whether the proposed plant would contribute to cumulative impacts.
- **Issue 4:** Whether the proposed plant would adversely affect quality of life.

#### Camilla Brannon

The Executive Director reviewed the factors found in 30 TAC § 55.201(c) and (d), and § 55.203 for determining whether a requestor is an affected person, and recommends the commission find that Camilla Brannon is not an affected person.

Camilla Brannon submitted one timely hearing request during the comment period. The hearing request was in writing and provided the required contact information. With the address provided by Ms. Brannon, the Executive Director determined that Ms. Brannon's residence is approximately 2665.37 yards from the proposed location of the plant, which is greater than 440 yards from the proposed plant. Therefore, the Executive Director requests that the Commission find that Camilla Brannon is not an affected person and that her hearing request be denied.

Aaron Brooks submitted one timely hearing request during the comment period. The hearing request was in writing and provided the required contact information. With the address provided by Mr. Brooks, the Executive Director determined that Mr. Brooks' residence is approximately 1137.37 yards from the proposed location of the plant, which is greater than 440 yards from the proposed plant. Therefore, the Executive Director requests that the Commission find that Aaron Brooks is not an affected person and that his hearing request be denied.

In his public hearing request, Aaron Brooks raised the following issues:

- **Issue 1:** Whether the permit would be protective of human health and safety.
- **Issue 2:** Whether the permit will negatively affect air quality.
- **Issue 3:** Whether the proposed plant would contribute to cumulative impacts.

Isabelle Canard submitted one timely hearing request during the comment period. The hearing request was in writing and provided the required contact information. With the address provided by Ms. Canard, the Executive Director determined that Ms. Canard's residence is approximately 2363.25 yards from the proposed location of the plant, which is greater than 440 yards from the proposed plant. Therefore, the Executive Director requests that the Commission find that Isabelle Canard is not an affected person and that her hearing request be denied.

# VI. WHETHER ISSUES RAISED ARE REFERRABLE TO SOAH FOR A CONTESTED CASE HEARING

The Executive Director has analyzed issues raised in accordance with the regulatory criteria. The issues discussed were raised during the public comment period and addressed in the RTC. None of the issues were withdrawn. For applications submitted on or after September 1, 2015, only those issues raised in a timely comment by a requestor whose request is granted may be referred.<sup>2</sup> The Executive Director does not recommend referral of any issues, because there are no affected persons in this matter.

#### VII. CONCLUSION

The Executive Director respectfully recommends the Commission:

- 1. Find the hearing requests in this matter were timely filed;
- 2. Find that no persons were affected; and




