COMMENTS: I 100% am apposed to a concrete plant being built on this site. I drive Silver Creek everyday to access the highway. It is my quickest route to church, work, grocery store, shopping, visiting family and friends. The community is outraged that this notice was advertised on a 2 x 4 sign on a curve in the road with no way to read or stop safely to read. This is another deceptive practice to not notify the community of zone changes that affect our property values, the air that we breath and the roads that we drive. Putting a notice in the newspaper is historic and not efficient to notify the people that would be affected by this plant. The dust that would be emitted by the plant is harmful to those that have limited lung capacity our elderly and children will be breathing this dust every single day. They say they will control the dust with water, but that will only create a mess on our road ways. The road is already a dangerous as it can be with huge trucks that drive to Silver Creek Materials. We battle the trucks that destroy our roads. They drive too fast, they turn left and drive down the rural road and cross ancient bridges that are not built for the weight of these trucks. Now add the trucks from this plant and we are adding to the danger that will affect our commute every single day. The trucks will not follow the laws of the road. None of them do as it is. I'm a Realtor and this will decrease the value of our home due to the road conditions to access our property and due to the quality of the air that we breath. I'm appalled at the inefficient delivery of notice that is given to the community. The word is slowly getting out and everyone agrees that the signs are too small to be read driving 35 miles around a curve with no safe way to stop and read the sign. Poor decision and deceptive practice of proper notice. We as a community do not want anymore large trucks on our small two lane rural road and bridges. Nor do we want to share this road with oversized and heavy weight being trucks that would be fatal if you were to be ht by one of these trucks driving on Silver Creek Rd. The lanes across these bridges are narrow and crossing one with a heavy truck and misjudging the distance can be fatal. Unfortunately, this has already proven to be true on this road. Please, I implore that this permit not be approved. There are plenty other places with better access and not close to homes.

Dear Chief Clerk,

The City of Fort Worth (City) respectfully submits this letter to express its opposition to the proposed Air Quality Standard Permit for the Raptor Ready Mix Inc. Concrete Batch Plant (Permit No. 177217L002), located off Silver Creek Road, Fort Worth, TX 76052.

If permitted, this facility will negatively impact and diminish the quality of life for City of Fort Worth residents living in proximity to it. The proposed site is also within 3,000 feet of Brewer High School, a sensitive receptor.

Furthermore, the TCEQ's protectiveness review relies on inadequate and outdated data that does not protect the health and safety of the public. As the EPA identified in its public comment for TCEQ's 2023 Amendments to the Air Quality Standard Permit for Concrete Batch Plants, TCEQ uses data from Victoria and Austin from 1983, 1984, 1986, 1987, and 1988 to perform its air dispersion modeling. The TCEQ should instead rely upon complete datasets from cities where TCEQ has service centers in each of TCEQ's service regions, instead of from cities over two-hundred miles away from Fort Worth.

The TCEQ indicates that it does not have jurisdiction to consider plant location choices made by an applicant when determining whether to approve or deny a permit application unless a statute or rule imposes specific distance limitations that are enforceable by the TCEQ. Zoning and land use are beyond the authority of the TCEQ to consider when reviewing air quality permit applications, and such issues should be directed to local officials.


In *Southern Crushed Concrete, LLC v. City of Houston*, the Texas Supreme Court held that the plain language of section 382.113(b) of the Texas Health and Safety

Code unmistakably forbids a city from nullifying an act that is authorized either by the Texas Clean Air Act, or the TCEQ's rules or orders. *See Southern Crushed Concrete, LLC v. City of Houston*, 398 S.W.3d 676, 679 (Tex. 2013). The Texas Supreme Court's ruling in *Southern Crushed Concrete* undermines the Executive Director's contention that commenters can address their concerns about plant location choices, zoning, land use, traffic, and other issues to local officials. Section 382.113(b) of the Health and Safety Code prevents local governments from "nullifying" what TCEQ has given its blessing to through a permit under the TCEQ's rules. The Texas Supreme Court ruled that a local government cannot "pass an ordinance that effectively moots a Commission decision." *Southern Crushed Concrete, LLC*, 398 S.W.3d at 679.

Therefore, the City requests a public meeting on the proposed permit to provide residents with an opportunity to better understand the facility's operations and potential impacts on their health and quality of life. This meeting would also allow citizens to submit comments regarding the proposal.

While the City supports businesses that seek to operate within our community, the proposed location of this facility is problematic due to its potential adverse effects on the surrounding environment and residents' quality of life. For these reasons, the City respectfully opposes the issuance of the referenced Air Quality Standard Permit for the concrete batch plant.
