EXECUTIVE DIRECTOR'S RESPONSE TO HEARING REQUESTS

I. INTRODUCTION

The Executive Director (ED) of the Texas Commission on Environmental Quality (Commission or TCEQ) files this Response to Hearing Requests on an application by City of Abilene (Applicant) for a new TPDES Permit No. WQ0005213000. II. FACILITY DESCRIPTION

City of Abilene, which owns a reverse osmosis water treatment facility, has applied to renew (TPDES) Permit No. WQ0005213000 (EPA I.D. No. TX0137383) to authorize the discharge of treated wastewater at a volume not to exceed an annual average flow of 1,510,000 gallons per day. The facility is located at 105 East Elliot Street, in the City of Breckenridge, Stephens County, Texas 76424. The discharge route is from the plant site directly to Possum Kingdom Lake in Segment No. 1207 of the Brazos River Basin. The applicant owns and proposes to operate the Possum Kingdom Raw Water Roughing Facility (RWRF), a reverse osmosis water treatment facility, which will treat Possum Kingdom Lake raw water with a microfiltration (MF) and reverse osmosis (RO) system. The authorization was initially issued on September 12, 2018. The renewal application is for a renewal without changes. The applicant has a satisfactory compliance rating. Additionally, because the facility has not begun operation, the site has an 'unclassified' compliance history designation.

The effluent is discharged directly to Possum Kingdom Lake in Segment No. 1207 of the Brazos River Basin. The designated uses for Segment No. 1207 are primary contact recreation, public water supply, and high aquatic life use. The effluent limits in the draft permit will maintain and protect the existing instream uses. All determinations are preliminary and subject to additional review and revisions. Segment No. 1207 is not currently listed on the state's inventory of impaired and threatened waters, the 2022 CWA § 303(d) list. There are no completed TMDLs for Segment No. 1207.

Possum Kingdom Lake raw water will be treated with a MF and RO system and transferred for additional water treatment prior to distribution. A portion of the raw surface water will undergo MF and RO to reduce chloride and Total Dissolved Solids (TDS) levels. A membrane feed pump station will transfer raw water from the raw water storage tank to the MF system. The MF system will consist of a primary recovery system and a tertiary recovery system designed to maximize recovery of raw water through the MF system. The primary and tertiary recovery MF systems will provide a net recovery of raw water of approximately 99%. The MF system will send MF filtrate feed water to a 3-stage RO system designed for 85-90% recovery depending on the season and raw water temperature. The RO permeate and untreated raw surface water will be blended together in the Product Water Storage Tank before being pumped to the City of Abilene Grimes Water Treatment Plant (WTP), the Northeast WTP, or both for complete water treatment. The quality of the product water will generally match raw water quality in Hubbard Creek Reservoir, which the RWRF water supply is intended to replace during the times of dry weather and drought. Reject water will be transferred offsite via approximately 24 miles of 12-inch PVC pipe to proposed Outfall 001 in the Cedar Creek Arm of Possum Kingdom Lake. The outfall will consist of a unidirectional multiport diffuser that is 12 meters long with 10 equally spaced ports.

The ports will be angled upwards at 60 degrees from the horizontal with the diffuser perpendicular to the bank so wastewater will be discharged generally parallel to the bank and toward the main pool of the lake. Each port will use a variable velocity orifice valve arranged in a fanned-out pattern. The port area will vary with effluent flow. Water treatment wastes will be discharged at an annual average flow of 1.09 MGD during Phase I and at an annual average flow of 1.51 MGD during Phase II via Outfall 001.

Other waste streams (tertiary MF backwash waste, MF and RO clean-in-place wastes, plant drains, and domestic wastewater) must be disposed of in an approved manner, such as routing to an authorized third party for treatment and disposal.

The discharge from this permit is not expected to have an effect on any federal endangered or threatened aquatic or aquatic-dependent species or proposed species or their critical habitat. This determination is based on the United States Fish and Wildlife Service's (USFWS's) biological opinion on the State of Texas authorization of the TPDES program (September 14, 1998; October 21, 1998 update). To make this determination for TPDES permits, TCEQ and the EPA only considered aquatic or aquatic-dependent species occurring in watersheds of critical concern or high priority as listed in Appendix A of the USFWS's biological opinion. The determination is subject to reevaluation due to subsequent updates or amendments to the biological opinion. The permit does not require EPA review with respect to the presence of endangered or threatened species.

III. PROCEDURAL BACKGROUND

The permit application was received on March 7, 2023, and declared administratively complete on June 16, 2023. The Notice of Receipt and Intent to Obtain a Water Quality Permit (NORI) was published on July 26, 2023, in the *Breckenridge American* and on June 22, 2023, in *La Prensa Comunidad*. The Notice of Application and Preliminary Decision (NAPD) was published on February 28, 2024, in the *Breckenridge American* and on March 5, 2024, in *La Prensa Comunidad*.

A Notice of Public Meeting was published on May 15, 2024, in the *Breckenridge American*. A public meeting was held, as scheduled, on June 18, 2024, at the Possum Kingdom Lake Chamber of Commerce in Graford, Texas. The hearing request period closed on July 28, 2025. This application was filed after September 1, 2015; therefore, this application is subject to the procedural requirements adopted pursuant to House Bill (HB) 801, 76th Legislature (1999), and Senate Bill (SB) 709, 84th Legislature (2015), both implemented by the Commission in its rules in 30 TAC Chapter 39, 50, and 55.

IV. THE EVALUATION PROCESS FOR HEARING REQUESTS

HB 801 established statutory procedures for public participation in certain environmental permitting proceedings, specifically regarding public notice and public comment and the Commission's consideration of hearing requests. SB 709 revised the requirements for submitting public comment and the Commission's consideration of hearing requests. The evaluation process for hearing requests is as follows:

A. Response to Requests

The ED, the Public Interest Counsel, and the Applicant may each submit written responses to a hearing request.¹

Responses to hearing requests must specifically address:

- (1) whether the requestor is an affected person;
- (2) which issues raised in the hearing request are disputed;
- (3) whether the dispute involves questions of fact or of law;

- (4) whether the issues were raised during the public comment period;
- (5) whether the hearing request is based on issues raised solely in a public comment withdrawn by the commenter in writing by filing a withdrawal letter with the chief clerk prior to the filing of the ED's Response to Comment;
- (6) whether the issues are relevant and material to the decision on the application; and
- (7) a maximum expected duration for the contested case hearing.²

B. Hearing Request Requirements

For the Commission to consider a hearing request, the Commission must first determine whether the request meets certain requirements:

Affected persons may request a contested case hearing. The request must be made in writing and timely filed with the chief clerk. The request must be based only on the requestor's timely comments and may not be based on an issue that was raised solely in a public comment that was withdrawn by the requestor prior to the filing of the ED's Response to Comment.³

A hearing request must substantially comply with the following:

- (1) give the time, address, daytime telephone number, and where possible, fax number of the person who files the request. If the request is made by a group or association, the request must identify one person by name, address, daytime telephone number, and where possible, fax number, who shall be responsible for receiving all official communications and documents for the group;
- (2) identify the person's personal justiciable interest affected by the application, including a brief, but specific, written statement explaining in plain language the requestor's location and distance relative to the proposed facility or activity that is the subject of the application and how and why the requestor believes he or she will be adversely affected by the proposed facility or activity in a manner not common to members of the general public;
- (3) request a contested case hearing;
- (4) list all relevant and material disputed issues of fact that were raised during the public comment period and that are the basis of the hearing request. To facilitate the commission's determination of the number and scope of issues to be referred to hearing, the requestor should, to the extent possible, specify any of the ED's responses to comments that the requestor disputes and the factual basis of the dispute and list any disputed issues of law; and
- (5) provide any other information specified in the public notice of application.⁴

C. Requirement that Requestor be an Affected Person/“Affected Person” Status

To grant a contested case hearing, the Commission must determine that a requestor is an “affected” person by conducting the following analysis:

- (a) For any application, an affected person is one who has a personal justiciable interest related to a legal right, duty, privilege, power, or economic interest affected by the application. An interest common to members of the general public does not qualify as a personal justiciable interest.
- (b) Except as provided by § 55.103 of this title (relating to Definitions), governmental entities, including local governments and public agencies, with authority under state law over issues raised by the application may be considered affected persons.
- (c) In determining whether a person is an affected person, all factors shall be considered, including, but not limited to, the following:
 - (1) whether the interest claimed is one protected by the law under which the application will be considered;
 - (2) distance restrictions or other limitations imposed by law on the affected interest;
 - (3) whether a reasonable relationship exists between the interest claimed and the activity regulated;
 - (4) likely impact of the regulated activity on the health and safety of the person, and on the use of property of the person;
 - (5) likely impact of the regulated activity on use of the impacted natural resource by the person;
 - (6) for a hearing request on an application filed on or after September 1, 2015, whether the requestor timely submitted comments on the application that were not withdrawn; and
 - (7) for governmental entities, their statutory authority over or interest in the issues relevant to the application.
- (d) In determining whether a person is an affected person for the purpose of granting a hearing request for an application filed on or after September 1, 2015, the commission may also consider the following:
 - (1) the merits of the underlying application and supporting documentation in the commission's administrative record, including whether the application meets the requirements for permit issuance;
 - (2) the analysis and opinions of the ED; and
 - (3) any other expert reports, affidavits, opinions, or data submitted by the ED, the applicant, or hearing requestor.
- (e) In determining whether a person is an affected person for the purpose of granting a hearing request for an application filed before September 1, 2015, the commission may also consider the factors in subsection (d) of this section to the extent consistent with case law.

D. Referral to the State Office of Administrative Hearings

“When the commission grants a request for a contested case hearing, the commission shall issue an order specifying the number and scope of the issues to be

referred to SOAH for a hearing.”⁵ The Commission may not refer an issue to the State Office of Administrative Hearings (SOAH) for a contested case hearing unless the Commission determines that the issue:

- (1) involves a disputed question of fact or a mixed question of law and fact;
- (2) was raised during the public comment period by an affected person whose hearing request is granted; and
- (3) is relevant and material to the decision on the application.⁶

E. Permit Applications When There is No Right to a Contested Case Hearing

30 TAC § 55.201(i)(5) outlines when a renewal or amended permit application proposed to be issued under the Texas Water Code, Chapter 26, is not subject to a contested case hearing. A permit renewal or amendment is not subject to a contested case hearing when:

- (A) The applicant is not applying to:
 - (i) increase significantly the quantity of waste authorized to be discharged; or
 - (ii) change materially the pattern or place of discharge;
- (B) the activity to be authorized by the renewal or amended permit will maintain or improve the quality of waste authorized to be discharged;
- (C) any required opportunity for public meeting has been given;
- (D) consultation and response to all timely received and significant public comment has been given; and
- (E) the applicant’s compliance history for the previous five years raises no issues regarding the applicant’s ability to comply with a material term of the permit.

30 TAC § 55.201(i)(5).

V. NO RIGHT TO A CONTESTED CASE HEARING

A. There is No Right to a Contested Case Hearing on this Renewal Application

This is an application for a renewal to an existing Texas Pollutant Discharge Elimination System Permit No. WQ0005213000, and the Commission must determine whether there is a right to a contested case hearing. The contested case hearing request in this case should be denied under TWC § 26.028(d) and 30 TAC § 55.201(i)(5), because there is no right to a contested case hearing for this permit renewal.

According to TCEQ rules, 30 TAC § 55.201(i)(5), there is no right to a contested case hearing for applications that seek to renew or amend a permit under Texas Water Code, Chapter 26, if: (1) the applicant is not applying to increase significantly the quantity of waste authorized to be discharged or change materially the pattern or place of discharge, (2) the activity to be authorized by the renewal or amended permit will maintain or improve the quality of waste authorized to be discharged, (3) any required opportunity for public meeting has been given, (4) consultation and response to all timely received and significant public comment was done, and (5) the Applicant’s

compliance history for the previous five years raises no issues regarding the Applicant's ability to comply with a material term of the permit.

The City of Abilene application seeks to renew Texas Pollutant Discharge Elimination System Permit No. WQ0005213000. The City of Abilene permit was previously issued in 2018. Effluent limitations and monitoring requirements in the draft permit remain the same as the existing permit effluent limitations and monitoring requirements. This permit renewal would authorize the discharge of treated domestic wastewater at a daily average flow not to exceed 1,510,000 gallons per day. The City of Abilene is not applying to increase the quantity of wastewater authorized to be disposed of. Therefore, the ED recommends finding that the application does not materially change the place or pattern of wastewater disposal from the existing permit and that the permit will maintain the quality of waste authorized to be discharged. Required opportunity for a public meeting has been given, approximately 350 public comment requests were received. The Applicant has a satisfactory compliance history rating, and the site has an unclassified compliance history rating. See Attachment A.

The fact that the facility has not yet been constructed does not itself create a right to a hearing. The ED does not condition the right to renew on whether construction has occurred – rather on compliance history, rule conformity, and timely filings. Therefore, the Applicant's compliance history raises no issues regarding the Applicant's ability to comply with the material terms of the permit.

The Executive Director recommends finding that this permit renewal application meets all of the conditions in 30 TAC § 55.201(i)(5) and that there is no right to a contested case hearing in this case.

VI. REQUESTS FOR RECONSIDERATION

TCEQ's rules provide that a Request for Reconsideration (RFR) must expressly state that the person is requesting reconsideration of the executive director's decision and provide reasons why the decision should be reconsidered. 30 TAC § 55.201(e). The Commission received timely RFRs from John Queralt and PKLA and the following individual members:

The issue raised by John Queralt is whether the draft permit will protect designated uses of the receiving water, specifically recreational use (RTC Response 2).

The issues raised by PKLA and its individual members are whether the draft permit is adequately protective of water quality along the discharge route and will maintain designated uses, such as recreational activities, in the receiving waters. (RTC Responses 1, 2, 3, and 21); Whether the draft permit adequately protects the drinking water supply of Possum King Lake (RTC Response 7); Whether the draft permit is adequately protective of water quality standards during drought and low-flow conditions (RTC Responses 8 and 23); Whether the application materials provided by the Applicant are accurate and complete (RTC Responses 11, 22, and 23).

These issues, to the extent they are within the Commission's jurisdiction to consider on a TPDES application, were considered during the ED's review of the application. The RFRs did not provide any new information that would lead the ED to change her recommendation on the application; therefore, the ED recommends denial of the RFRs.

VII. CONCLUSION

The Executive Director recommends the following actions by the Commission:

1. Find that there is no right to a contested case hearing.
2. Deny all requests for reconsideration.

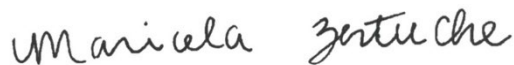

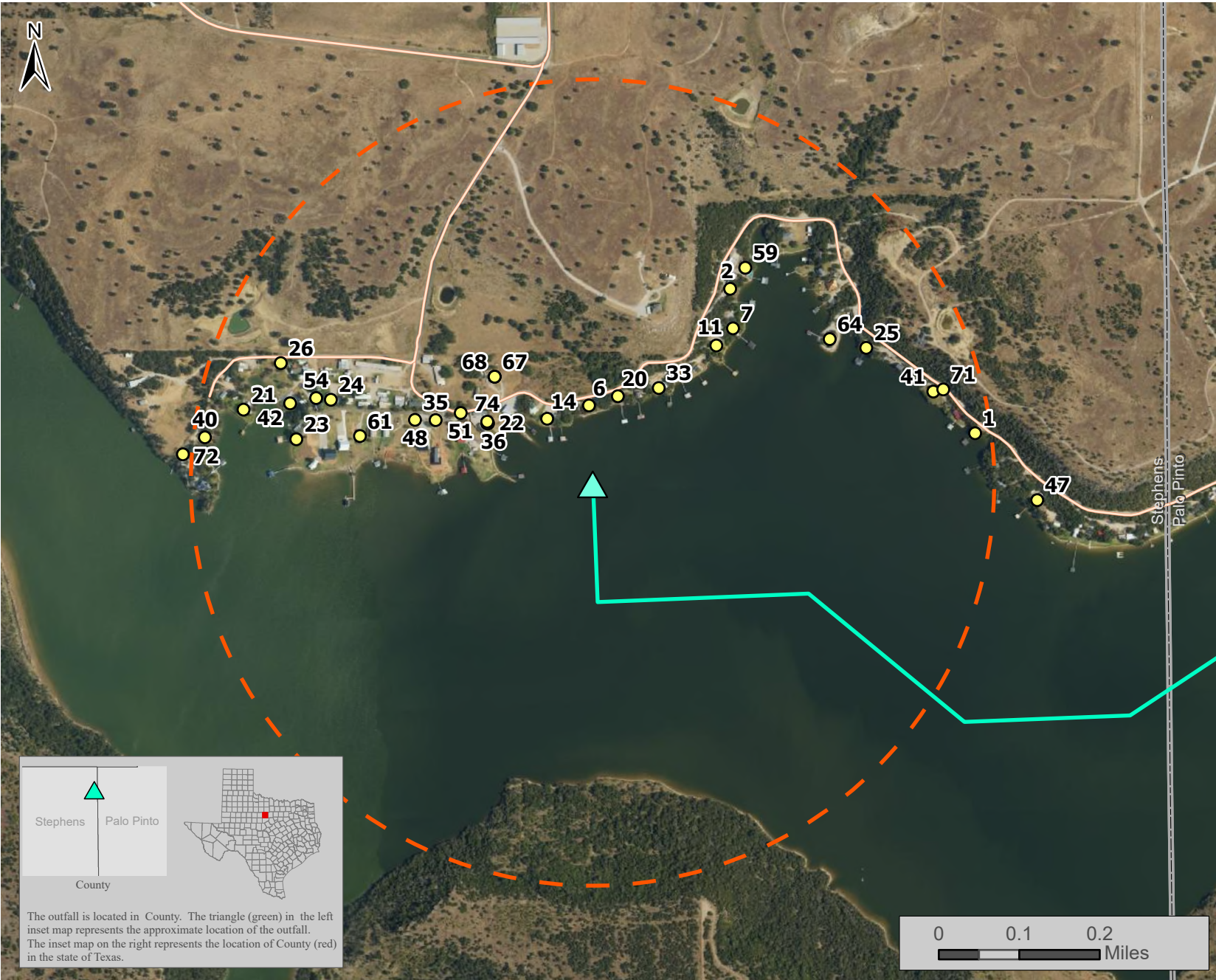

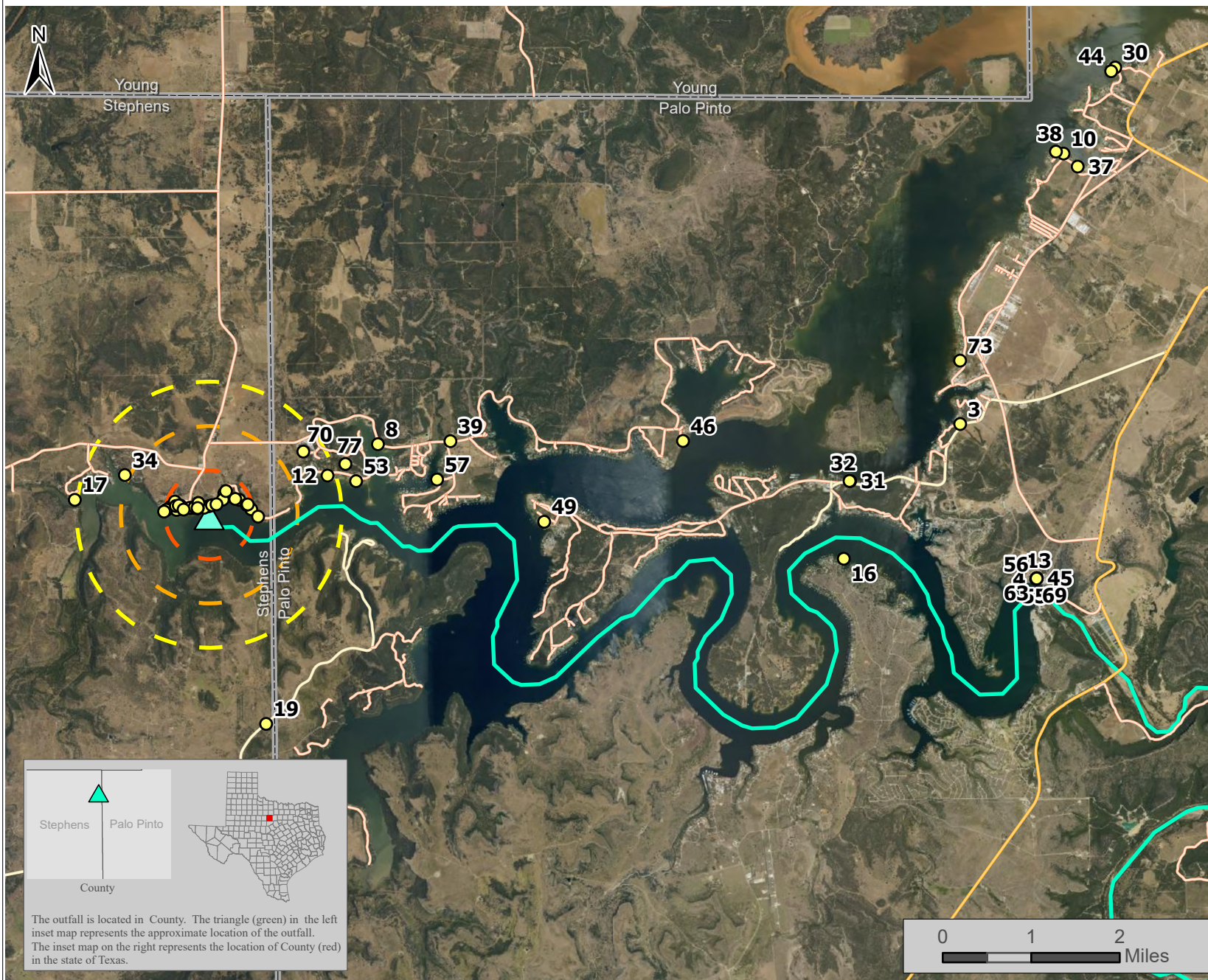

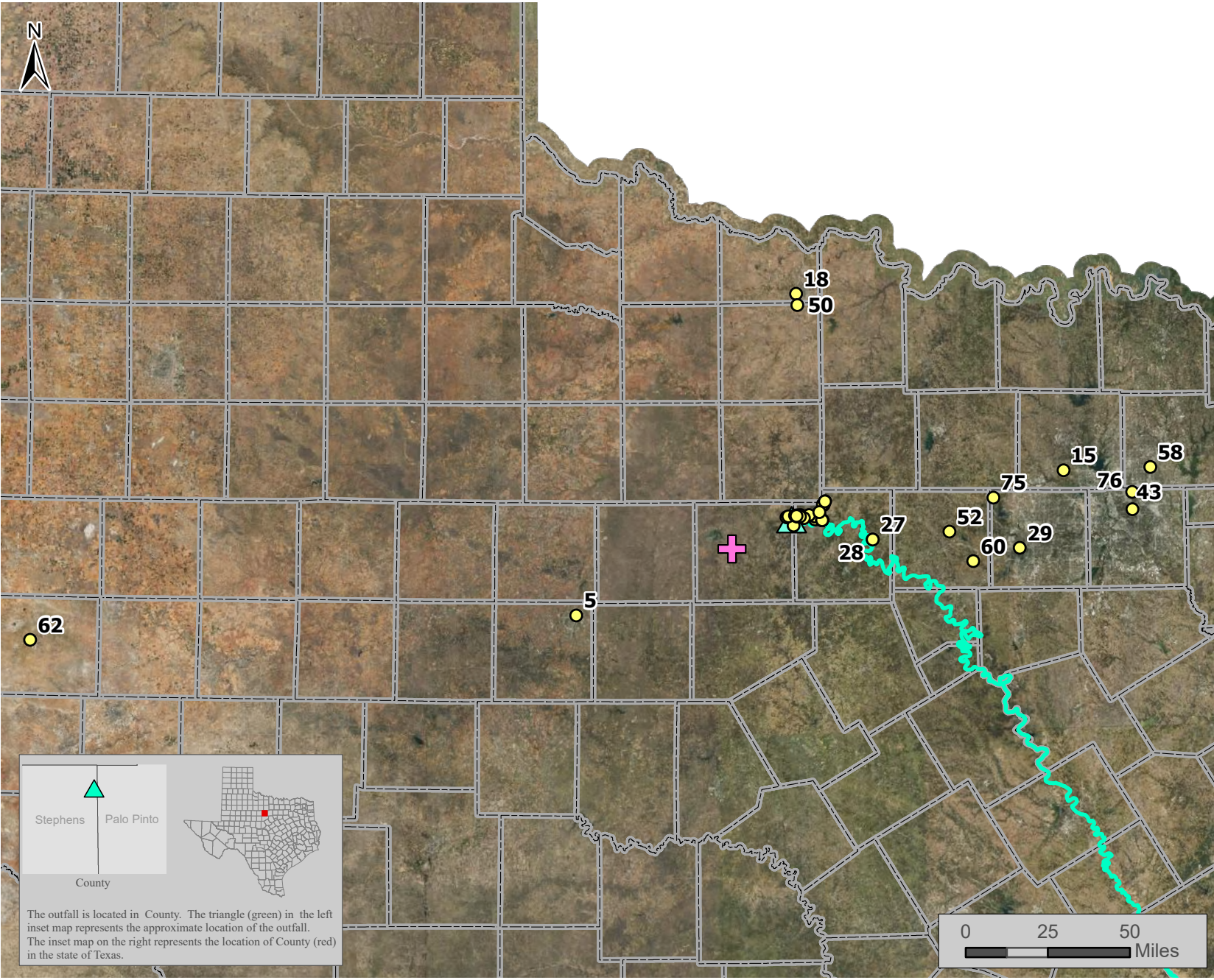
