I would like to express our concerns about the permit application for a Wastewater Treatment Facility (WQ0016524001) located near Salado on FM2843. We are concerned about the discharge affecting the Edwards Aquifer and wells that draw from the Edwards Aquifer. Discharge will be sent into Mustang Greek which flows into Salado Creek, a recharge zone where faults and fractures allow

surface water to flow into the groundwater putting wells at risk. Mustang Creek is federally registered by the U.S. Fish and Wildlife Service as a Critical Habitat for the endangered Salado Salamander, an animal found only in the spring fed waters of a few creeks. (Salado Salamander Monitoring Final Report 2020) 3) The Department of Fish and Wildlife regularly monitors Mustang Creek and its springs located on our property. They have found snails that have only been found in our springs. 4) Mustang Creek flows through over 30 properties in Hidden Springs, which is located less than 2 miles from the Mustang Springs Development. COMMENTS: We request a copy of the Preliminary Design Report for the WWTP design that lays out the type and size of the facility, and the related phases planned. We request a formal site layout of the proposed plant and its relationship to our property. We further request a copy of the draft TCEQ permit for this facility. This proposed WWTP borders our property and main entrance, and it may have stream quality impact through our property. As we understand it, 1,000,000 gallons of discharge, which is the

projected discharge for this facility, is equivalent to the discharge output of approximately 100,000 people. This is an excessively large amount of discharge planned for what has been marketed as serving 600 homes. The projected discharge of effluent is planned to be at a basin that runs dry 3 months out of the year. The rest of the year, it flows directly into our livestock ponds and then flows into Salado Creek. This leads to two concerns: a. amount of discharge into creeks and b. quality of water discharged into our basin, livestock ponds, and creeks. We have been told that the WWTP will be enclosed, we obviously do not want to see, smell nor hear the facility. We want assurances that the WWTP is enclosed. We further want a clear understanding of the plan for disposal locations and treatment, storage, and a handling of the disposal of the waste solids and effluent disposal areas. Will there be back-up power required by TCEQ for this permit? Will Mustang Springs Utility LLC, be a current registered utility provider permit holder? And if so, what other facilities do they currently hold and maintain? In conclusion, we are concerned about the longevity of this facility, how it will affect our property, our legacy and our investment. We are stewards of this land and water resources. TCEQ Representatives,

Thank you for the opportunity to provide public comment regarding the Mustang Springs Discharge Permit. My name is Whitney Ingram, Assistant General Manager for Clearwater Underground Water Conservation District. We are very pleased with the leadership of Representative Brad Buckly and his staff who called this public meeting, allowing local citizens to be engaged in the review of this permit.

I want to begin by saying that our District aligns with the enhanced changes made in this permit, as compared to the first permit request submitted by Mustang Springs. These modifications reflect a necessary and responsible approach to safeguarding our groundwater resource in the Edwards BFZ Aquifer which extends from the Belton along IH35 to Uvalde Texas.

Given this precedent, we strongly recommend that TCEQ adopt the same requirements and conditions for all future discharge permits over the outcrop of the Edwards BFZ Aquifer and the spring shed of Salado Creek which lies in Bell County and our jurisdiction. The TCEQ Edwards Aquifer Protection Plan does not cover the full extent of the Edwards boundaries into Bell County which causes concerns from our District. It is critical that we protect the underlying ground water of Bell County with the same level of scrutiny and regulation that TCEQ applies south into Williamson County. There is no reason for a regulatory gap to exist simply due to jurisdictional boundaries. TCEQ has the authority to take action without requiring legislative changes by ensuring that all future discharge permits in Bell County are held to the same standards.

Clearwater Underground Water Conservation District is the only scientific-based regulatory agency in Bell County. However, we have no authority over discharge permits. Despite this, we consistently intercede and advocate on behalf of groundwater users, a process that places a significant financial burden on local taxpayers. Establishing clear guidelines that align with what is now being implemented in this permit would provide consistency, reduce unnecessary costs, and ensure stronger protection for our shared water resources.

In closing, I encourage TCEQ to make this approach the standard practice when reviewing similar applications. Doing so would create a fair, protective, and scientifically sound regulatory process that benefits both the environment and the communities that rely on these vital water sources.

We gratefully embrace this process for public comment, called for by our state representative. Thank you for your time and consideration. If you have any further questions, please do not hesitate to contact me.





AT PUBLIC MEETING

I am writing to strongly oppose the approval of TCEQ Permit No.: WQ0016524001, which would authorize the discharge of up to one million gallons of treated wastewater per day into Mustang Creek. The proposed discharge into Mustang Creek presents unacceptable risks to water quality, human health, and the environment.

The introduction of such a substantial volume of treated wastewater raises significant concerns. Even treated wastewater contains a complex mixture of substances that pose potential risks. Research has consistently demonstrated the presence of the following in treated wastewater:

- **Pathogens:** While treatment reduces pathogen levels, it does not eliminate them entirely. Bacteria like *E. coli*, viruses, and protozoa can still be present, posing a risk of waterborne illnesses, especially to children who are more vulnerable. A study published in the *Journal of Environmental Health* found that even treated wastewater can contain antibiotic-resistant bacteria, a growing public health concern. This is particularly concerning for children who are more susceptible to infections.
- Pharmaceuticals and Personal Care Products (PPCPs): These emerging contaminants, including medications, hormones, and personal care products, are often not fully removed by conventional wastewater treatment. Studies have shown that PPCPs can disrupt the endocrine systems of aquatic organisms, leading to reproductive problems and other health issues. The US Geological Survey has documented the presence of PPCPs in streams across the US, including those near wastewater treatment plants. The long-term effects of PPCPs on human health are still being studied, but their presence in our waterways is cause for serious concern.
- Nutrients: Excess nitrogen and phosphorus can lead to eutrophication, a process where excessive nutrient enrichment causes algal blooms. These blooms deplete oxygen in the water, harming aquatic life and creating "dead zones." The EPA recognizes nutrient pollution as a major water quality problem nationwide. Eutrophication can also lead to foul odors and decreased recreational value of the creek.
- Heavy Metals and Other Pollutants: Depending on the source of the wastewater, heavy metals and other industrial chemicals could be present, even after treatment. These can accumulate in the food chain and pose risks to both aquatic life and human health. The potential for heavy metal contamination is a particular concern given the proximity to the Edwards Aquifer recharge zone.

Recharge Zone Vulnerability and the Edwards Aquifer: Mustang Creek lies within the contributing zone of the Edwards Aquifer, a vital drinking water source for many Texans. Introducing treated wastewater into this recharge zone carries the risk of contaminating the aquifer. While the aquifer provides some natural filtration, studies have shown that it may not be sufficient to remove all contaminants from treated wastewater, including nitrates, phosphates, and PPCPs. This poses a long-term threat to the quality of our groundwater resources. Protecting the Edwards Aquifer is paramount, as it is a critical source of drinking water for present and future generations.

Impact on Endangered Species and Precedent Setting: Mustang Creek joins Salado Creek at 30°56′ N, 97°35′ W, which is only 2.5 miles downstream of the proposed water treatment plant. We would like to see Mustang Springs Development utilize a land application to keep all effluent discharge on the Mustang Springs property.
