Re: Motion to Overturn filed by the Executive Director concerning the Executive Director's September 30, 2025, decision to grant Travis County Water Control and Improvement District No. 17's Texas Land Application Permit No. WQ0013878001; TCEQ Docket No. 2025-1629-MWD.

This letter is in response to the Motion to Overturn (Motion) filed on October 23, 2025, by the Executive Director, requesting that the Commission overturn the Executive Director's approval of Travis County Water Control and Improvement District No. 17's Texas Land Application Permit No. WQ0013878001 to correct a procedural error in the Executive Director's processing of the public comments on this application. Title 30, Section 50.139 of the Texas Administrative Code authorizes the General Counsel to extend the time for the Commission to act on a motion to overturn up to 90 days after the date written notice of the Executive Director's action is mailed to the Applicant. Accordingly, this letter shall serve as the order extending the time for the Commission to act on the Motion until **Wednesday, December 17, 2025**.
